ADDENDUM NO. 5

Invitation To Bid (ITB) No. 24-101640, Pedestrian Crossing on Pleasantdale Road is hereby amended as follows:

1. The due date for bids has been extended to **Tuesday, April 9, 2024, by 3:00 P.M. (EST).**
2. **DELETE/REMOVE:** Page 17, BIDDER'S UNIT PRICE FORM and **INSERT/REPLACE:** with the Revised Page 17, BIDDER'S UNIT PRICE FORM attached hereto. Please ensure you complete and submit the attached BIDDER's UNIT PRICE FORM with your bid in a separate sealed envelope.
3. We have received questions pertaining to this Invitation To Bid. The questions and their resulting answers appear below:
 - A. **Question:** It appears that the Power Services are not indicated on the maps. Could you clarify if the county will be responsible for providing the power and obtaining the necessary permits?

Answer: The contractor is responsible for establishing the power connections.

- B. **Question:** According to the Bidder's Unit Price Form, it specifies a STEEL STRAIN POLE, TP IV, including a 50FT MAST ARM. However, the Signal Plans indicate the use of 40' and 45' Mast Arms instead. Additionally, the plans detail the requirement for (3) STEEL STRAIN POLES, TP IV, with a 40FT MAS ARM and another (3) with a 45FT MAST ARM. Could you please confirm if this information is accurate?

Answer: The plans call for one pole with 40-foot mast arm, three poles with 45-foot mast arms, and two poles with 50-foot mast arms. The Revised Bidder's Unit Price Form attached hereto has been modified to reflect the changes.


