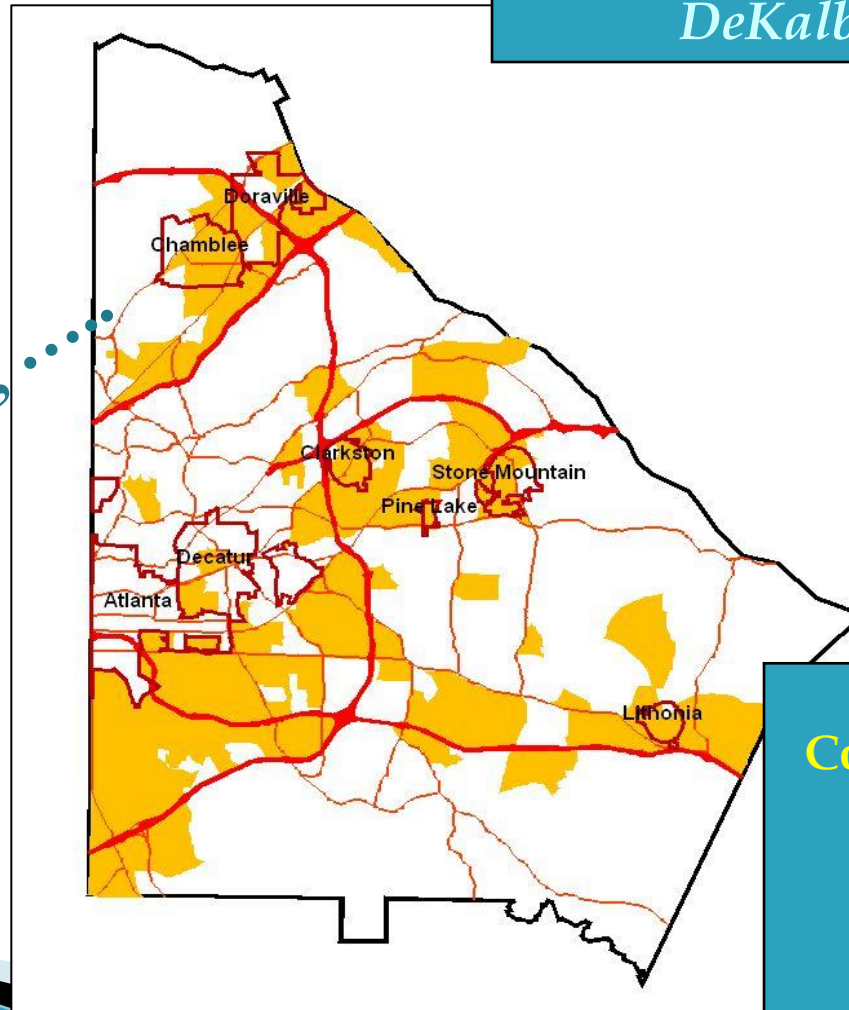

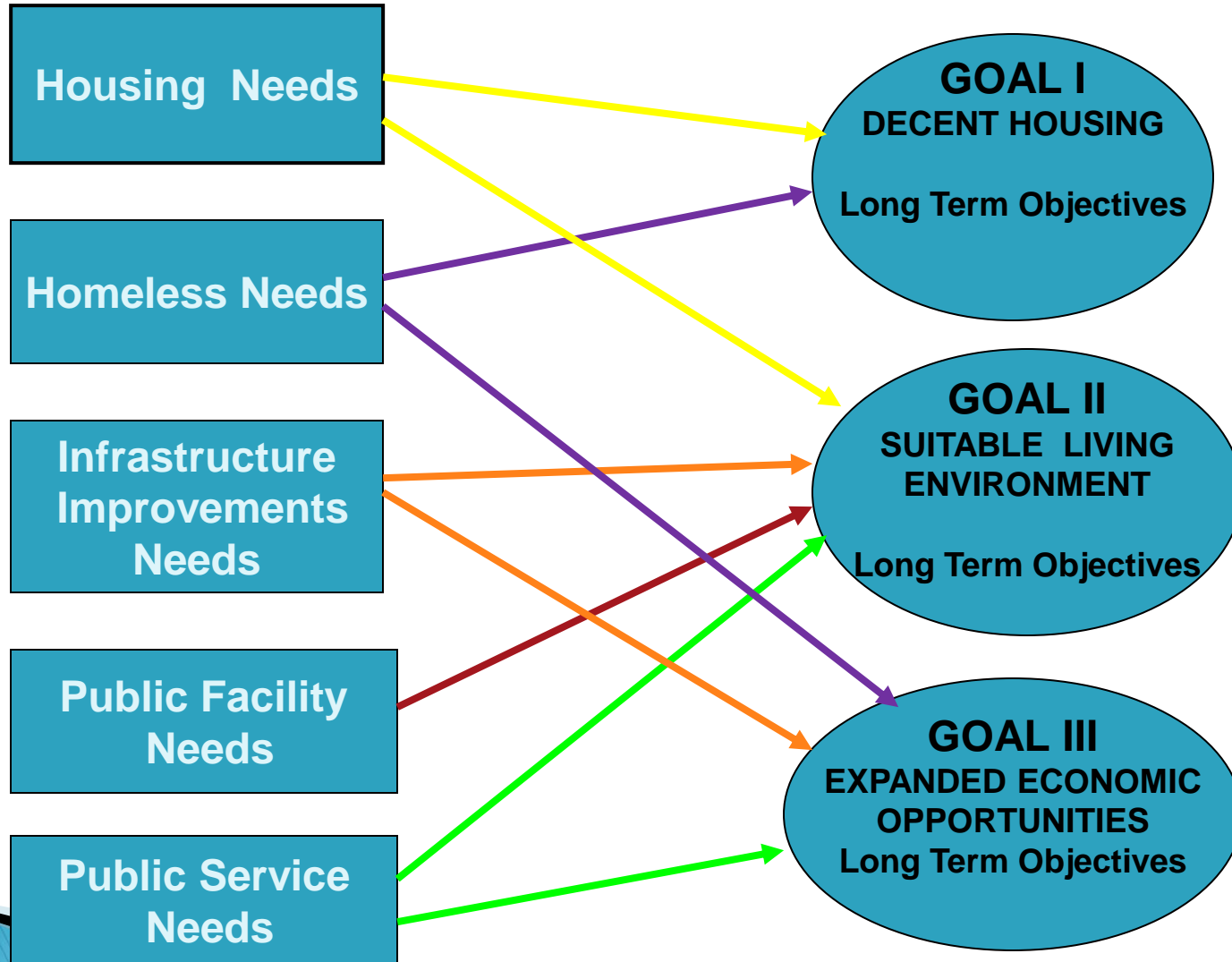
Community Needs/ Priorities

- ▶ **March 4, 2021**: **Technical Assistance Workshop**, – Via Zoom
- ▶ **March 11, 2021**: **Public Hearing**, 6:00pm – Via Zoom The purpose of this hearing is to solicit input from the public regarding community needs and priorities. We will discuss general information concerning the 2020 Annual Action Plan submission process as well as HUD updates and changes.
- ▶ **March 31, 2021**: **Completed applications** requesting FY 2021 funds must be received by the DeKalb County Community Development Department March 31, 2021, ***NO LATER THAN 1:00 P.M.***

(Continued)

- ▶ **April 29, 2020: Public Hearing**, Via Zoom –The purpose of this hearing is to present the **Draft Update to the 2019–2023 Consolidated Plan including the 2021 Annual Action Plan**, proposed budget and solicit public questions and/or comments.
- ▶ **August 9, 2021: DEADLINE** to submit the 2019–2023 Consolidated Plan including the 2021 Annual Action Plan to HUD.
- ▶ **TBD**: The contract preparation process begins for 2021 grant awardees.
- ▶ **January 2022**: Most contracts are effective.
