DeKalb County Government (the County) requests qualified firms who are certified by the Georgia State Board of Workers' Compensation and who have experience in Bill Review and Pharmaceutical Management Services to submit proposals to direct and manage medical and rehabilitative services for its employees injured on the job.

I. INTRODUCTION

A. General Information

The primary mission of this RFP is to identify the best and most qualified Bill Review and Pharmaceutical Management Services Organization. The County's objective is to control costs and maintain or enhance the quality of medical and related care provided to injured employees through the panel of physicians' bill review and pharmaceutical care. **Attachment C** is a breakdown by year of relevant claim statistical data. The County's workers compensation program is self-insured and self-administered, utilizing the Origami claims system. The Workers' Compensation Manager of the County's Risk Management and Employee Services Division will have oversight of the awarded Bill Review and Pharmaceutical Management Services Organization.

B. Guarantee for Pharmaceutical Management Services After Contract Award

Pharmaceutical Management is a specialized service and the selected provider must be capable of electronic data interchange (EDI) with the County, at no additional expense to the County.

C. Guarantee for Bill Review Services After Contract Award

Bill Review is a specialized service and the selected provider must be capable of (ready-now)

electronic data interchange (EDI) with the County, at no additional expense to the County.

- **E.** The services shall commence within ten (10) calendar days after acknowledgement of receipt of written notice to proceed and shall be completed in accordance with the agreed on detailed project plan included in vendor's proposal.
- **F.** The County reserves the right to make one (1) award or multiple awards.

II. SCOPE OF WORK

A. Description of Tasks

Workers' Compensation claims are self-insured and self-administered by Dekalb County Risk Management. Claims are administered in accordance to industry Best Claim Practices. Therefore, Risk Management is searching for responders who will partner in this effort and commit to providing a quality service promptly.

Services sought include, at a minimum, the following services:

- 1. Printed materials including state form WC-P1, Panel of Physicians. Wallet reference card or other printed materials required by the State Board of Workers' Compensation to be distributed to employees. It is expected that these materials will be supplied at no additional charge to the County.
- 2. Pharmaceutical management program where injured workers can receive medications from their local pharmacy with no out of pocket expense.
- 3. Create Panel of Physicians

- 4. Any other service(s) related to a Panel, not specifically listed above, that should reasonably be provided.
- 5. Medical providers' bill review and re-pricing including individual Explanation of Benefits form.
- 6. Management reports to include:
 - a. Monthly Disability Duration Reports breakdown, by claimant, of all claims received by work status full duty release, light duty release, lost days within waiting period, lost-time (exceeding waiting period).
 - b. Year-to-date (YTD) Disability Duration Report same as the above but running tally and status of all claims received on a year-to-date (YTD) basis.
 - c. Monthly Lost-time Report Summary of lost time (> 7 days) claims by department/cost center showing the total number days lost during the month.
 - d. Monthly Bill Review Savings Report summary report of bill review services provided, savings achieved for the County, and Case Management costs incurred to generate the savings. The report should in particular specify the number bills, number lines, provide.

B. Results or Outcome of Task

The tasks to be accomplished include orientation and training of County employees; the preparation and distribution of required printed materials; the providing of medical case management services, both telephonic and on-site for catastrophic and non-catastrophic cases alike; the providing of bill review re-pricing and/or check issuance services; vocational rehabilitation services on catastrophic cases.

C. Completion Schedules

Bill Review should be reviewed and re-priced timely so that the data can be transferred to the County (via EDI). Full compliance with Rule 203 where applicable. In no event should bills be paid later than thirty (30) days of receipt of a properly itemized bill with necessary medical records, in protection of the County against late payment penalties, fines, interest and other civil actions that could be imposed by the State Board of Workers' Compensation.

D. Performance and Quality Standards

Responder must also be familiar with the Fraud provisions in the Workers' Compensation Act and be specifically familiar with O.C.G.A. Section 34 -9-19 regarding penalties for false or misleading statements made for the purpose of obtaining or denying benefits under the act.

The successful responder will have on staff representatives and supervisors who will be available to provide prompt, professional and cost-effective repricing as needed or upon Order of the Board. The proposal shall include resumes for the staff members who will be assigned to the Dekalb County Risk Management account with the requirements as identified in Section III, A, 3(Personnel) of this RFP. Subcontracted employees must be specifically identified and their use will require the advance approval of Dekalb County Risk Management.

E. Progress Reporting

Explanation of Benefits, as completed by the Representative, should be provided to the County's Risk Management (RM) and Employee Services Division on-line via email or by fax. Additionally, the Representative will provide Risk Management (RM) with medical reports as received, either via scanning on-line (emailed to RM) or by fax. On-line transmission is preferred. Additionally, management reports will be provided to Risk Management.

F. Place of Performance

The Bill Review and Pharmaceutical Services will perform services from their own place of business, with fieldwork completed where and when needed. Work is generally conducted in the Metro Atlanta Area.

G. County Furnished Property/Services

The County will provide meeting facilities as needed. As agreed to by the parties, the County may furnish physical space for a Bill Review and Pharmaceutical Services employee to provide on-site services. In the event of the latter, the WC Bill Review and Pharmaceutical Services would be expected to provide furniture and equipment, computers, telephones, and other supplies necessary to carry out the assigned duties of the Bill Review and Pharmaceutical Services staff.

H. Contractor Furnished Items

The Bill Review and Pharmaceutical Management Services will provide all needed supplies to include pen, paper, audio recording equipment, computers, printers, telephones, calculators, and other furniture and equipment necessary for the rendering of contracted services

I. Payments and Taxes

The responder must present a fixed cost proposal in the form attached (Attachment A) to this Request for Proposal. Such cost proposal must include all costs (separate provisions for per diem will not be accepted). DeKalb County is a tax-exempt political subdivision of the State of Georgia.

III. PROPOSAL FORMAT

Responders are required to submit their proposals in the following format:

A. Cost Proposal

The cost proposal must be submitted in a separate, sealed envelope with the responder's name and "Cost Proposal for Request for Proposals (RFP) No. 23-500652 for Workers' Compensation Bill Review and Pharmaceutical Management Services" on the outside of the envelope.

- 1. The <u>sealed envelope containing the cost proposal</u> is requested to be included in the sealed package containing the technical proposal.
- 2. DO NOT INCLUDE FEES OR COSTS IN ANY AREA OUTSIDE OF THIS COST PROPOSAL. Including fees in any area outside of the Cost Proposal in its separate, sealed envelope shall result in Responder's proposal being deemed non-responsive.
- 3. Responders are required to submit their costs on Attachment A, Cost Proposal Form. Responder shall not alter the cost proposal form.

B. Technical Proposal

DO NOT INCLUDE ANY COSTS OF ANY KIND IN THE TECHNICAL PROPOSAL OR ON THE DISCS CONTAINING THE TECHNICAL PROPOSAL.

Technical Proposals must be submitted in a sealed envelope(s) or box(es) with the responder's name and "Request for Proposals (RFP) No. 23-500652 for Workers' Compensation Bill Review and Pharmaceutical Management Services" on the outside of each envelope or box.

Responder shall complete Attachment B, *Proposal Cover Sheet*, and include this as the first page of the technical proposal.

1. Technical Approach (15)

Responders are required to describe the procedures and methods that will achieve the required outcome of this project. Attach a copy of their suggested Panel of Physicians that is outlined by the State requirements of:

The minimum panel shall consist of at least six physicians; including an orthopedic surgeon with no more than two physicians from industrial clinics (see O.C.G.A. 34-9-201). Further, this panel shall include one minority physician; whenever feasible (see Rule 201 for definition of minority physician). The Board may grant exceptions to

the required size of the panel where it is demonstrated that more than four physicians are not reasonably accessible.

a. Medical Bill Review

- 1. Describe the process by which medical fees are checked against the Workers Compensation Fee Schedule. Is this service administered from a centralized office? If the fee schedule is handled at other location, please indicate location.
- 2. Describe, in detail, your bill review system capabilities. Specifically address the following issues:
 - a. How is the information captured during bill review integrated with medical management and the claims administrator?
 - b. The capabilities of the system (e.g., the systems you have to prevent duplicate claims, inappropriate/unnecessary services, comparison to Usual & Customary, unbundling, ability to recognize multiple PPO and negotiated fee arrangements.).
- 3. Do you provide nurse reviews of workers' compensation medical bills to ensure services are reasonable and necessary?
- 4. Are your medical and hospital bill review services automated or manual?
- 5. How are bills picked up and delivered? Any additional cost to the county for this service?
- 6. Are you able to transmit bill review results via EDI into the Origami format? If not, are you able to match the Origami protocol for EDI.

2. Project Management (15)

Describe how the project will be organized and managed. Include the anticipated use of subcontractors. Include a description of equipment used and/or other state of the art resources for completing assigned tasks. Please include answers to the following questions specifically:

Note: If selected for an interview by the Evaluation Committee, responder will be required to do a test batch of approximately 25 bills to submit to DeKalb County for evaluation of services and cost savings. In addition, responder will be required to provide a sample report for each of the major services you provide (i.e., intake sheet for new cases; initial case management report, subsequent case management report, closing; and disability duration report.

- 5. Please provide a sample of your Explanation of Benefits form.
- 6. Based on an average of 346 bills per month and 941 lines per month, how many employees would be assigned to process the County's bills?
- 7. Would the work be spread over all employees, or would there be designated staff to handle the County's bills?
- 8. What are your performance results, for all clients combined, in the following service areas for the last full calendar year?
- 9. Is there integration of your bill review and case management systems? Explain.
- 10. How are bills picked up and delivered? Any additional cost to the county for this service?
- 11. Bill review and re-pricing, including individual Explanation of Benefits form: Attach sample of form. Is form attached? YES____No___.
- 12. What is your turnaround time for this service?
- 13. Is your method for unbundling charges electronic or manual?
- 14. Would the work be spread over all employees, or would there be designated staff to handle the County's bills?
- 15. Is there integration of your bill review and case management systems? Explain.

b. <u>Pharmaceutical Services</u>

1. Provide information on your typical savings for pharmacy network services. Respondent –if selected as a finalist respondent, you may be required to do a test batch of approximately 25 prescriptions to submit to Dekalb County Georgia for evaluation of services and cost savings.

- 2. Describe the process for pharmaceutical management, average savings earned, and the number of pharmacies in the program.
- 3. Is this your own network or a sub-contracted network?
- 4. Describe the process for pharmaceutical management, average savings earned, concurrent and retrospective drug utilization review, drug compensability screening, formulary management and the number of pharmacies in the program. Is this your own network or a sub-contracted network?

3. Personnel (10)

Identify the individuals who will be handling assignments for DeKalb County Risk Management. Subcontractors regularly used by your firm should be identified All staff members must meet or exceed the following:

- 1. Experience of the Supervisor: The Supervisor overseeing telephonic and field case management shall have a minimum of six (6) years case management experience involving workers' compensation claims.
- 2. Experience of Staff (Per individual): Case Managers assigned to handle the claims for the County shall have a minimum of three (3) years experience involving workers' compensation claims.
- 3. <u>Certifications:</u> The responder must include in the resumes of the proposed staff members, an outline of Industry education and certifications that both Supervisor(s) and case managers have successfully completed.

4. Organizational Qualifications (15)

1. Describe your experience, capabilities and other qualifications. Provide the total number of employees in your organization (per location if multiple locations involved), with a breakdown of the number by position held. Include a current Financial Statement and a minimum of five (5) business references. Include name and address of reference, contact person, and contact person's phone number, fax number and email address.

2. Insurance

- i. List all forms of casualty insurance which your Bill Review and Pharmaceutical Services carries and agrees to maintain in force for the duration of the contract.
- ii. At a minimum, the Bill Review and Pharmaceutical Services selected must provide to the County Certificates of Insurance from companies doing business in Georgia and acceptable to the County covering:

- (a) **Statutory workers' compensation insurance** or proof that the Bill Review and Pharmaceutical Services is not required to provide such coverage under State law;
- (b) **Medical malpractice insurance** on the medical services provided (if the Bill Review and Pharmaceutical Services provides direct medical care) in this agreement with limits of at least \$1,000,000, or proof that the Bill Review and Pharmaceutical uses independent medical care providers and requires at least \$1,000,000 malpractice coverage from each; and
- (c) Commercial General Liability coverage limits:
 - \$1,000,000 each accident for Bodily Injury
 - \$1,000,000 Personal & Advertising Injury
 - \$2,000,000 General Aggregate
 - \$2,000,000 Products/Completed and Operations
 - \$ 100,000 Property Damage Liability
 - \$ 5,000 Medical Expense (Any one Person)
- (d) Auto Liability Insurance
 - \$500,000 Combined Single limit for Bodily Injury or Property Damage
- (e) \$1,000,000 Umbrella Liability Insurance policy with General Liability, Auto Liability and Employers Liability scheduled as underlying policies.

5. Performance and Quality Standards (15)

1. Medical bill Review

- a. What is your method for quality assurance of bill review to duplicate payments and the avoidance of other overpayments of medical?
- e. What are your performance results, for all clients combined, in the following service areas for the last full calendar year?
 - i. Average number bills and number lines per month.

 - iv. Average savings and percent savings due to other discounts per month.
 - v. Total average savings and percent savings from all sources combined per month.
 - vi. Average fees for bill review per month based on fee per bill. Also based on fee per line.
- 2. <u>Pharmacy Services.</u> Provide information on your typical savings for pharmacy network services.

6. Financial Responsibility (5)

Responder must provide financial statements for the last three (3) years that evidences the responder's financial capabilities to perform the scope of work. (Audited statements are preferable but a minimum of balance sheet, income statement and cash flow statement may be accepted.) Provide year of incorporation (if applicable).

7. References (5)

- a. Responder shall provide three (3) references for projects similar in size and scope to the project specified herein using the *Reference and Release Form* attached hereto as Attachment E.
- b. Provide three (3) references for each subcontractor proposed as a part of the project team. The references shall be for the same or similar types of services to be performed by the subcontractor (including LSBE-DeKalb and LSBE-MSA firms) on projects similar in size and scope to the project outlined in this RFP. Use Attachment F, Subcontractor Reference and Release Form. Make additional copies as needed.
- **8. Provide the following information**: Are you a DeKalb County Firm? Yes/No.

V. CONTRACT ADMINISTRATION

A. Standard County Contract

The attached sample contract is the County's standard contract document (see Attachment K), which specifically outlines the contractual responsibilities. All responders should thoroughy review the document prior to submitting a proposal. Any proposed revisions to the terms or language of this document must be submitted in writing with the responder's response to the request for proposals. Since proposed revisions may result in a proposal being rejected if the revisions are unacceptable to the County, responders should review any proposed revisions with an officer of the firm having authority to execute the contract. No alterations can be made in the contract after award by the Board of Commissioners.

E. Acknowledgment of Addenda

Addenda may be issued in response to changes in the RFP. It is the responsibility of the responder to ensure awareness of all addenda issued for this solicitation. Please acknowledge the addenda and submit to the Department of Purchasing and Contracting as requested. F. Proposal Duration

Proposals submitted in response to this RFP must be valid for a period of One Hundred Twenty (120) days from proposal submission deadline and must be so marked.

G. Project Director/Contract Manager

The County will designate a Project Director/Contract Manager to coordinate this project for the County. The successful responder will perform all work required pursuant to the contract under

the direction of and subject to the approval of the designated Project Director/Contract Manager. All issues including, payment issues, shall be submitted to the Project Director/Contract Manager for resolution.

H. Expenses of Preparing Responses to this RFP

The County accepts no responsibility for any expenses incurred by the responders to this RFP. Such expenses are to be borne exclusively by the responders.

I. Georgia Open Records Act

Without regard to any designation made by the person or entity making a submission, DeKalb County considers all information submitted in response to this invitation or request to be a public record that will be disclosed upon request pursuant to the Georgia Open Records Act, O.C.G.A. §50-18-70 et seq., without consulting or contacting the person or entity making the submission, unless a court order is presented with the submission. You may wish to consult an attorney or obtain legal advice prior to making a submission.

J. First Source Jobs Ordinance

The DeKalb County First Source Jobs Ordinance requires contractors or beneficiaries entering into any type of agreement with the County, including purchase orders, regardless of what they may be called, for the procurement or disposal of supplies, services, construction projects, professional or consultant services, which is funded in whole or part with County funds or County administered funds in which the contractor is to receive \$50,000 or more in County expenditures or committed expenditures and recipient of urban redevelopment action grants or community development block funds administered in the amount of \$50,000 or more make a good faith effort to hire DeKalb County residents for at least 50% of jobs using the First Source Registry (candidate database). The work to be performed under this contract is subject to the provisions of the DeKalb County First Source Jobs Ordinance. K. Business License

L. Ethics Rules

Bidders are subject to the Ethics provision within the DeKalb County Purchasing Policy; the Organizational Act, Section 22A, the Code of DeKalb County; and the rules of Executive Order 2014-4. Any violations will be addressed, pursuant to these policies and rules.

To the extent that the Organizational Act, Section 22A, the Code of DeKalb County, and the rules of Executive Order 2014-4 allow a gift, meal, travel expense, ticket, or anything else of value to be purchased for a CEO employee by a contractor doing business with the County, the contractor must provide written disclosure, quarterly, of the exact nature and value of the purchase to the Chief Integrity Officer, if created, or the Finance Director or his/her designee. Every contractor conducting business with the County will receive a copy of these ethical rules at the time of execution of the contract.

M. Right to Audit

The County shall have the right to audit all books and records, including electronic records, relating or pertaining to this contract or agreement, including but not limited to all financial and performance related records, property, and equipment purchased in whole or in part with County funds and any documents or materials which support those records, kept under the control of the Contractor, including but not limited to those kept by the Contractor's employees, agents, assigns, successors and subcontractors. The County also has the right to communicate with Contractor's employees related to the audited records.

The Contractor shall maintain such books and records, together with such supporting or underlying documents and materials, for the duration of this contract and for seven (7) years after termination or expiration, including any and all renewals thereof. The books and records, together with supporting documents and materials shall be made available, upon request to the County or its designee, during normal business hours at the Contractor's office or place of business. In the event that no such location is available, then the books, records, and supporting documents shall be made available for audit at a time and location which is convenient for the County.

N. Cooperative Procurement

The County through the Department of Purchasing and Contracting may permit piggybacks to this contract from other city, county, local authority, agency, or board of education if the vendor will extend the same prices, terms, and conditions to the city. Piggybacking shall only be available where competition was used to secure the contract and only for a period of 12-months following entry, renewal or extension of the contract. This provision shall not apply to any contract where otherwise prohibited or mandated by state law.

VI. AWARD OF CONTRACT

An evaluation committee will review and rate all proposals and shall determine if interviews are necessary.

If interviews are conducted, firms will be scheduled for an oral presentation to the evaluation committee, not to exceed one hour's duration, to respond to questions from the evaluation committee relevant to the firm's proposal.

The evaluation committee will make its recommendation for award to the DeKalb County Board of Commissioners. who will make the final decision as to award of contract.

THE COUNTY RESERVES THE RIGHT TO REJECT ANY AND ALL PROPOSALS, TO WAIVE INFORMALITIES, AND TO RE-ADVERTISE.

Certified Local Small Business Enterprises (LSBEs) located within DeKalb County and prime contractors utilizing LSBEs that are locally-based inside DeKalb County shall receive ten (10) points in the initial evaluation of their response to any Request for Proposal. LSBE participation, or otherwise required benchmark, then the Prime Contractor who actually met the benchmark will be given the opportunity to match the lowest bid price of the Prime Contractor who only made good faith efforts. As required by O.C.G.A §36-60-13, this Contract shall (i) terminate without further obligation on the part of the County each and every December 31st, as required by O.C.G.A. § 36-60-13, as amended, unless terminated earlier in accordance with the termination provisions of this Contract; (ii) automatically renew on each January 1st, unless terminated in accordance with the termination provisions of this Contract; and (iii) terminate absolutely, with no further renewals, on December 31, 20XX, unless extended by Change Order adopted and approved by the DeKalb County Governing Authority and the Contractor in accordance with the terms of this Contract.

ARTICLE III. PAYMENT

The term "Change Order" includes the term "amendment" and shall mean a written order authorizing a change in the Work, and an adjustment in Contract Price to Contractor or the Contract Term, as adopted and approved by the Contractor and the DeKalb County Governing Authority, or the Chief Executive Officer, if exempted from Governing Authority adoption and approval in accordance with the express terms of this Contract. The Chief Executive Officer or his/her designee shall have the authority to approve and execute a Change Order lowering the Contract Price or increasing the Contract Price up to twenty percent (20%) of the original Contract Price, provided that the total amount of the increase authorized by such Change Order is less than \$100,000.00. If the original Contract or Purchase Order Price does not exceed \$100,000.00, but the Change Order will make the total Contract Price exceed \$100,000.00, then the Change Order will require approval by official action of the Governing Authority. Any other increase of the Contract Price shall be by Change Order adopted and approved by the DeKalb County Governing Authority and the Contractor in accordance with the terms of this Contract. The Contractor's services shall include all things, personnel, and materials necessary to accomplish specific projects authorized by the County. Specific Work Authorizations will have precedence over any interpretation within the Contract.

ARTICLE V. GENERAL CONDITIONS

- A. <u>Accuracy of Work</u> The Contractor shall be responsible for the accuracy of the Work and any error and/or omission made by the Contractor in any phase of the Work under this Agreement.
- B. Additional Work The County shall in no way be held liable for any work performed under this section which has not first been approved in writing by the County in the manner required by applicable law and/or the terms of this Contract. The County may at any time order changes within the scope of the Work without invalidating the Contract upon seven (7) days written notice to the Contractor. The Contractor shall proceed with the performance of any changes in the Work so ordered by the County unless such change entitles the Contractor to a change in Contract Price, and/or Contract Term, in which event the Contractor shall give the County written notice thereof within fifteen (15) days after the receipt of the ordered change, and the Contractor shall not execute such changes until it receives an executed Change Order from the County. No extra cost or extension of time shall be allowed unless approved by the County and authorized by execution of a Change Order. The parties' execution of any Change Order constitutes a final settlement of all matters relating to the change in the Work which is the subject of the Change Order. The County shall not be liable for payment for any work performed under this section which has not first been approved in writing by the County in the manner required by applicable law and/or the terms of this Contract.
- C. <u>Ownership of Documents</u> All documents, including drawings, estimates, specifications, and data are and remain the property of the County. The Contractor agrees that the County may reuse any and all plans, specifications, drawings, estimates, or any other data or documents described herein in its sole discretion without first obtaining permission of the Contractor and without any payment of any monies to the Contractor therefore. However, any reuse of the documents by the County on a different site shall be at its risk and the Contractor shall have no liability where such documents are reused.
- D. <u>Right to Audit</u> The County shall have the right to audit all books and records, including electronic records, relating or pertaining to this contract or agreement, including but not limited to all

financial and performance related records, property, and equipment purchased in whole or in part with County funds and any documents or materials which support those records, kept under the control of the Contractor, including but not limited to those kept by the Contractor's employees, agents, assigns, successors and subcontractors. The County also has the right to communicate with Contractor's employees related to the audited records.

The Contractor shall maintain such books and records, together with such supporting or underlying documents and materials, for the duration of this contract and for seven (7) years after termination or expiration, including any and all renewals thereof. The books and records, together with supporting documents and materials shall be made available, upon request to the County or its designee, during normal business hours at the Contractor's office or place of business. In the event that no such location is available, then the books, records, and supporting documents shall be made available for audit at a time and location which is convenient for the County.

- E. <u>Successors and Assigns</u> The Contractor agrees it shall not sublet, assign, transfer, pledge, convey, sell, or otherwise dispose of the whole or any part of this Contract or his right, title, or interest therein to any person, firm, or corporation without the previous written consent of the County. If the County consents to any such assignment or transfer, then the Contractor binds itself, its partners, successors and assigns to all covenants of this Contract. Nothing contained in this Contract shall create, nor be interpreted to create privity, or any other relationship whatsoever, between the County and any person, or entity or than Contractor.
- F. <u>Reviews and Acceptance</u> Work performed by the Contractor shall be subject to review and acceptance in stages as required by the County. Acceptance shall not relieve the Contractor of its professional obligation to correct, at his own expense, any errors in the Work.
- G. Termination of Agreement The Contractor understands and agrees that the date of the beginning of Work, rate of progress, and time for completion of the Work are essential conditions of this Contract. The County may, for its own convenience and at its sole option, without cause and without prejudice to any other right or remedy of County, elect to terminate the Contract by delivering to the Contractor, at the address listed in the Notices article of this Contract, a written notice of termination specifying the effective date of termination. Such notice shall be delivered to Contractor at least thirty (30) days prior to the effective date of termination. If Contractor's services are terminated by the County, the termination will not affect any rights or remedies of the County then existing or which may thereafter accrue against Contractor or its surety. In case of termination of this Contract before completion of the Work, Contractor will be paid only for the portion of the Work satisfactorily performed through the effective date of termination as determined by the County. Neither party shall be entitled to recover lost profits, special, consequential or punitive damages, attorney's fees or costs from the other party to this Contract for any reason whatsoever. This Contract shall not be deemed to provide any third-party with any remedy, claim, right of action, or other right. The parties' obligations pursuant to this Section shall survive any acceptance of Work, or termination or expiration of this Contract.
- H. <u>Indemnification Agreement</u> The Contractor shall be responsible from the execution date or from the time of the beginning of the Work, whichever shall be the earlier, for all injury or damage of any kind resulting from the Work, to persons or property, including employees and property of the County. The Contractor shall exonerate, indemnify, and save harmless the County, its elected officials, officers, employees, agents and servants, hereinafter collectively referred to in this Section as "the County Indemnitees," from and against all claims or actions based upon or arising out of any damage or injury (including without limitation any injury or death to persons and any damage to property) caused by or sustained in connection with the performance of this Contract or by conditions created thereby or arising out of or any way connected with Work performed under this Contract, as well as all expenses incidental to the defense of any such claims, litigation, and actions. Furthermore, Contractor shall assume and pay for, without cost to the County Indemnitees, the defense of any and

all claims, litigation, and actions suffered through any act or omission of the Contractor, or any Subcontractor, or anyone directly or indirectly employed by or under the supervision of any of them. Notwithstanding any language or provision in this Contract, Contractor shall not be required to indemnify any County Indemnitee against claims, actions, or expenses based upon or arising out of the County Indemnitee's sole negligence. As between the County Indemnitees and the Contractor as the other party, the Contractor shall assume responsibility and liability for any damage, loss, or injury, including death, of any kind or nature whatever to person or property, resulting from any kind of claim made by Contractor's employees, agents, vendors, Suppliers or Subcontractors caused by or resulting from the performance of Work under this Contract, or caused by or resulting from any error, omission, or the negligent or intentional act of the Contractor, vendors, Suppliers, or Subcontractors, or any of their officers, agents, servants, or employees. The Contractor shall defend, indemnify, and hold harmless the County Indemnitees from and against any and all claims, loss, damage, charge, or expense to which they or any of them may be put or subjected by reason of any such damage, loss, or injury. The Contractor expressly agrees to provide a full and complete defense against any claims brought or actions filed against the County Indemnitees, where such claim or action involves, in whole or in part, the subject of the indemnity contained in this Contract, whether such claims or actions are rightfully or wrongfully brought or filed. The County has the sole discretion to choose the counsel who will provide the defense. No provision of this Contract and nothing herein shall be construed as creating any individual or personal liability on the part of any elected official, officer, employee, agent or servant of the County, nor shall the Contract be construed as giving any rights or benefits hereunder to anyone other than the parties to this Contract. The parties' obligations pursuant to this Section shall survive any acceptance of Work, or termination or expiration of this Contract.

- I. <u>Insurance</u> Prior to commencing work, Contractor shall, at its sole expense, procure and maintain insurance of the types and in the amounts described below from insurer(s) authorized to transact business in the state where the work or operations will be performed by Contractor. - 8. Failure of the County to demand such certificate or other evidence of full compliance with these insurance requirements or failure of the County to identify a deficiency from evidence provided will not be construed as a waiver of the Contractor's obligation to maintain such coverage. Contractor understands and agrees that the purchase of

- insurance in no way limits the liability of the Contractor.
- 9. Certificates shall state that the policy or policies shall not expire, be cancelled or altered without at least sixty (60) days prior written notice to the County. Policies and Certificates of Insurance listing the County and its officers as additional insureds (except for workers' compensation insurance) shall conform to all terms and conditions (including coverage of the indemnification and hold harmless agreement) contained in this Contract.
- 10. If the County shall so request, the Contractor will furnish the County for its inspection and approval such policies of insurance with all endorsements, or confirmed specimens thereof certified by the insurance company to be true and correct copies. Contractor shall be responsible and have the financial wherewithal to cover any deductibles or retentions included on the certificate of insurance.
- J. Georgia Laws Govern The laws of the State of Georgia shall govern the construction of this Contract without regard for conflicts of laws. Should any provision of this Contract require judicial interpretation, it is agreed that the court interpreting or construing the same shall not apply a presumption that the terms hereof shall be more strictly construed against one party, by reason of the rule of construction, that a document is to be construed more strictly against the party who itself or through its agent prepared same; it being agreed that the agents of all parties have participated in the preparation hereof, and all parties have had an adequate opportunity to consult with legal counsel. In interpreting this Contract in its entirety, the printed provisions of this Contract, and any additions written or typed hereon, shall be given equal weight, and there shall be no inference by operation of law or otherwise; that any provision of this Contract shall be construed against either party hereto.
- K. <u>Venue</u> This Agreement shall be deemed to have been made and performed in DeKalb County, Georgia. For the purposes of venue, all suits or causes of action arising out of this Agreement shall be brought in the courts of DeKalb County, Georgia.
- L. Contractor and Subcontractor Evidence of Compliance; Federal Work Authorization Pursuant to O.C.G.A. §13-10-91, the County cannot enter into a contract for the physical performance of services unless the Contractor, its Subcontractor(s) and sub-subcontractor(s), as that term is defined by state law, register and participate in the Federal Work Authorization Program to verify specific information on all new employees. Contractor certifies that it has complied and will continue to comply throughout the Contract Term with O.C.G.A. §13-10-91 and any related and applicable Georgia Department of Labor Rule. Contractor agrees to sign an affidavit evidencing its compliance with O.C.G.A. §13-10-91. The signed affidavit is attached to this Contract as Attachment B. Contractor agrees that in the event it employs or contracts with any Subcontractor(s) in connection with this Contract, Contractor will secure from each Subcontractor an affidavit that certifies the Subcontractor's current and continuing compliance with O.C.G.A. §13-10-91 throughout the Contract Term. Any signed Subcontractor affidavit(s) obtained in connection with this Contract shall be attached hereto as Attachment C. Each Subcontractor agrees that in the event it employs or contracts with any sub-subcontractor(s), each Subcontractor will secure from each sub-subcontractor an affidavit that certifies the sub-subcontractor's current and continuing compliance with O.C.G.A. §13-10-91 throughout the Contract Term. Any signed sub-subcontractor affidavit(s) obtained in connection with this Contract shall be attached hereto as Attachment D.
- M. <u>County Representative</u> The County may designate a representative through whom the Contractor will contact the County. In the event of such designation, said representative shall be consulted and his written recommendation obtained before any request for extra work is presented to the County. Payments to the Contractor shall be made only upon itemized bill submitted to and approved by said representative.
 - N. Contractor's Status The Contractor will supervise and direct the Work, including the Work

of all Subcontractors. Only persons skilled in the type of work which they are to perform shall be employed. The Contractor shall, at all times, maintain discipline and good order among his employees, and shall not employ any unfit person or persons or anyone unskilled in the work assigned him. The relationship between the County and the Contractor shall be that of owner and independent contractor. Other than the consideration set forth herein, the Contractor, its officers, agents, servants, employees, and any Subcontractors shall not be entitled to any County employee benefits including, but not limited to social security, insurance, paid annual leave, sick leave, worker's compensation, free parking or retirement benefits. All services provided by Contractor shall be by employees of Contractor or its Subcontractors and subject to supervision by Contractor. No officer or employee of Contractor or any Subcontractor shall be deemed an officer or employee of the County. Personnel policies, tax responsibilities, social security payments, health insurance, employee benefits and other administrative policies, procedures or requirements applicable to the Work or services rendered under this Contract shall be those of the Contractor, not the County.

- O. <u>Georgia Open Records Act</u> Contractor shall comply with the applicable provisions of the Georgia Open Records Act, O.C.G.A. §50-18-70 *et seq*.
- P. <u>First Source Jobs Ordinance and Preferred Employees</u> The Contractor is required to comply with the DeKalb County First Source Jobs Ordinance, Code of DeKalb County as Revised 1988, section 2-231 *et seq.*, and among other things, is required to make a good faith effort to hire DeKalb County residents for at least fifty percent 50% of all jobs created by an Eligible Project, as that term is defined in the First Source Ordinance, using the First Source Registry. Contractors, subcontractors, and independent contractors bidding on this contract will be encouraged by DeKalb County to have 25% or more of their labor forces for this project consist of Preferred Employees selected from the First Source Registry. The First Source Registry has Preferred Employees trained by U.S. Department of Labor registered apprenticeship programs and other partners. For information on Preferred Employees, please contact the DeKalb County Workforce Development by telephone at 404-687-3417 or 404-687-7171or in person at 320 Church Street, Decatur, GA 30030.
- Q. <u>Business License</u> Contractor shall submit a copy of its current, valid business license with this Contract. If the Contractor is a Georgia corporation, Contractor shall submit a valid county or city business license. If Contractor is a joint venture, Contractor shall submit valid business licenses for each member of the joint venture. If the Contractor is not a Georgia corporation, Contractor shall submit a certificate of authority to transact business in the state of Georgia and a copy of its current, valid business license issued by its home jurisdiction. If Contractor holds a professional license, then Contractor shall submit a copy of the valid professional license. Failure to provide the business license, certificate of authority, or professional license required by this section, may result in the Contract being terminated. Contractor shall ensure that any insurance, license, permit or certificate submitted in response to the County's RFP or as part of the Contract shall be current and valid when submitted, and shall remain valid, current and maintained in good standing for the Contract Term.
- R. <u>Sole Agreement</u> This Contract constitutes the sole contract between the County and the Contractor. The terms, conditions, and requirements of this Contract may not be modified, except by Change Order. No verbal agreement or conversation with any officer, agent, or employee of the County, either before or after the execution of the Contract, shall affect or modify any of the terms or obligations herein contained. No representations, oral or written, shall be binding on the parties unless expressly incorporated herein. No Change Order shall be enforceable unless approved by official action of the County as provided by law or in this Contract.
- S. <u>Attachments and Appendices</u> This Contract includes the following Attachments and Appendices all of which are incorporated herein by reference: Attachment A, Contractor's Cost Proposal; Appendix I, County's RFP; Appendix II, Contractor's Response; Attachment B, Contractor's Affidavit; Attachment C, Subcontractor's Affidavit(s); Attachment D, Subsubcontractor's Affidavit(s); and Attachment E, Certificate of Corporate Authority or Joint Venture

Certificate.

- T. <u>Severability</u> If any provision of this Contract or the application thereof to any person or circumstance shall to any extent be held invalid, then the remainder of this Contract or the application of such provision to persons or circumstances, other than those as to which it is held invalid, shall not be affected thereby, and each provision of this Contract shall be valid and enforced to the fullest extent permitted by law.
- U. <u>Notices</u> Any notice or consent required to be given by or on behalf of any party hereto to any other party hereto shall be in writing and shall be sent to the County's Chief Executive Officer and the Executive Assistant or to the Contractor or his authorized representative on the work site by (a) registered or certified United States mail, return receipt requested, postage prepaid, (b) personal delivery, or (c) overnight courier service. All notices sent to the addresses listed below shall be binding unless said address is changed in writing no less than fourteen days before such notice is sent. Future changes in address shall be effective upon written notice being given by the Contractor to the County's Executive Assistant or by the County to the Contractor's authorized representative via certified first class U.S. mail, return receipt requested. Such notices will be addressed as follows:


