# I. INTRODUCTION

#### A. <u>Background and Purpose:</u>

The DeKalb County Planning & Sustainability Department is seeking proposals from qualified firms to provide consulting services for updates to the *Zoning Ordinance* and the *Sign Ordinance*.

The purpose of this project is to initiate significant updates to the DeKalb County Zoning Ordinance and the DeKalb County Sign Ordinance. Respectively, the Zoning Ordinance regulates land use and development activity, and the Sign Ordinance regulates signage throughout the unincorporated area of the County. The County recently passed the 2050 Unified Plan, which consists of the Comprehensive Transportation Plan (CTP) and Comprehensive Plan documents. Following up on the tremendous success of that community engagement effort is the need to update the aforementioned ordinances in order to implement the goals and action items from the 2050 Unified Plan. The anticipated work allocation between the two documents is 70:30, Zoning Ordinance and Sign Ordinance, respectively.

The last major update of the Zoning Ordinance was in 2015. Several text amendments have been made since that time. In addition to implementation of the 2050 Unified Plan, this update seeks to modernize the current Ordinance to meet contemporary and future land development needs and desires while balancing public health, safety, and welfare. Furthermore, DeKalb seeks to modernize the Ordinance to include streamlined procedures, increased illustrations, and simplified language to increase public understanding. The bulk of the updates should focus on the use table; development standards for residential, commercial, and mixed-use development; parking standards; consideration of no more than five (5) new special purpose districts; refinement of existing zoning districts; administrative procedures; and updated terms/definitions. Adjustment to overlay districts, if any, will be minimal. Along with the 2050 Unified Plan amendments, the process will present an opportunity to update the Sign Ordinance. The last ordinance update was 2003; approximately 20 years ago.

The goal of this update is to create clear, comprehensive sign regulations that effectively balance legitimate business and development needs with a safe and aesthetically attractive environment for residents, workers, and visitors to DeKalb County now and into the future. Given the relatively modest size of the Sign Ordinance, a full update of administrative procedures and sign standards along with sufficient illustrations within the current format is desired.

\*Failure to return these attachments with your proposal will render your proposal nonresponsive. If a firm and/or its subcontractor is exempt from completing Attachment C or D according to O.C.G.A. §13-10-91, the firm/subcontractor must state so and provide supporting details. The firm must provide alternate documentation upon request if required.

# II. SCOPE OF WORK

In addition to general code writing proficiency, the qualified entity should have basic legal code writing expertise and knowledge of applicable Georgia zoning statutes. The qualified entity may include two or more firms working together as a joint venture or in a prime-sub contractor relationship. It is anticipated that the project will commence by December 31, 2026. All work and services required under a subsequent agreement shall be completed on or before **July 31, 2027**.

Following acceptance of a proposal, the County and the successful responder will determine the final scope of work and prioritize it to delineate the specific responsibilities, the deliverable products, and schedule for completion. The proposal should include the number of work hours anticipated to accomplish each task. General descriptions of major work tasks are outlined in Attachment A, *Scope of Work*, attached hereto and included herein by reference.

# III. PROPOSAL FORMAT

Responders are required to submit their proposals in the following format:

# A. Cost Proposal

- The cost proposal must be submitted in a separate, sealed envelope with the Responder's name and "Cost Proposal for Request for Proposals No. 24-500671 for Zoning Ordinance & Sign Ordinance Update Project" on the outside of the envelope.
- 2. The sealed envelope containing the cost proposal is requested to be included in the sealed package containing the technical proposal.
- 3. DO NOT INCLUDE FEES OR COSTS IN ANY AREA OUTSIDE OF THIS COST PROPOSAL. Including fees in any area outside of the Cost Proposal in its separate, sealed

envelope shall result in Responder's proposal being deemed non-responsive.

4. Responders are required to submit their costs on Attachment B, *Cost Proposal Form*. Responder shall not alter the cost proposal form.

# **B.** Technical Proposal

- Responders should complete Attachment K, *Proposal Cover Sheet*, and include this as the first page of the technical proposal, followed by the Introduction, Technical Approach, Project Management, Organizational Qualifications, Personnel, Financial Responsibility, References, and the remaining required documents (see Section I. B. for the list of required documents). <u>To ensure that all requested information is captured in the proposal, Responder should use the format as provided below to respond to this RFP. The Technical Proposal shall not contain any cost information, or the proposal will be deemed non-responsive.

- 2. Technical Proposals must be submitted in a sealed envelope(s) or box(es) with the Responder's name and "**Request for Proposals No. 24-500671 for Zoning Ordinance & Sign Ordinance Update Project**," on the outside of each envelope or box.

# DO NOT INCLUDE ANY COSTS OF ANY KIND IN THE TECHNICAL PROPOSAL.

3. Introduction:

Provide general information about your company to include:

- a. Firm name and address;
- b. Former firm names, joint venture information, out of state offices, as applicable;
- c. A statement of which office shall handle the project, if multiple offices exist;
- d. A statement of whether you are a DeKalb County firm or not.
- e. A clear and concise response as to why the County should select your firm for this project;
- f. A list of any litigations, arbitrations, or mediations in which the firm has been involved in the past five (5) years involving claims for more than \$50,000 made by a County against the firm or by the firm against the County, and indicate the disposition of each claim, the name of the County, and the nature of the claim; and
- g. A statement that the proposal shall remain in effect for and not be withdrawn for onehundred fifty (150) days after the due date to the County.
- 4. Technical Approach:
  - a. Responders are required to describe the procedures and methods that will achieve the required outcome of the project as specified herein;
  - b. Include a listing of the County's responsibilities and the Responder's responsibilities required to complete the project; and
  - c. Provide a project schedule at the task level starting with the receipt of the Notice to Proceed and ending with project completion.
- 5. Project Management:
  - a. Describe how the project will be organized and managed;
  - b. Describe progress reporting procedures for the project;

- c. Include the anticipated use of subcontractors or vendors; and
- d. Describe the resources necessary to accomplish the purpose of the project.
- 6. Personnel:
  - a. Identify the individuals who will be part of the project team;
  - b. Include any outside personnel, such as subcontractors; and
  - c. Provide detailed resumes of team members and subcontractors who will be directly working on the project.
- 7. Organizational Qualifications:
  - a. Describe Responder's experience, capabilities and other qualifications for this project;
  - b. How many years has Responder operated under current company name?
  - c. Has Responder ever been debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded by any Federal department or agency from doing business with the Federal Government?
- 8. Responder must provide financial statements for the last three (3) years that evidences the responder's financial capabilities to perform the scope of work. (Audited statements are preferable but a minimum of balance sheet, income statement and cash flow statement may be accepted.) Provide year of incorporation/establishment.
- 9. References:
  - a. Responder shall provide three (3) references for projects similar in size and scope to the project specified herein using the *Reference and Release Form* attached hereto as Attachment E.
  - b. Provide three (3) references for each subcontractor proposed as a part of the project team. The references shall be for the same or similar types of services to be performed by the subcontractor (including LSBE-DeKalb and LSBE-MSA firms) on projects similar in size and scope to the project outlined in this RFP. Use Attachment F, Subcontractor Reference and Release Form. Make additional copies as needed.

# C. DeKalb First Ordinance

- 1. It is the objective of the Chief Executive Officer and Board of Commissioners of DeKalb County to provide maximum practicable opportunity for all businesses to participate in the performance of government contracts. The current DeKalb County List of Certified DeKalb First Local Small Business Enterprise (LSBE) Vendors may be found on the DeKalb County website.
- 2. It is required that all Responders attend the mandatory LSBE meeting within twoweeks of the solicitation's advertisement, and comply with, complete and submit all LSBE forms (Attachment G, *DeKalb First LSBE Information with Exhibits 1 and 2*) with the proposal in order to remain responsive. # **D.** Federal Work Authorization Program Contractor and Subcontractor Evidence of Compliance

All qualifying Responders and subcontractors performing work with DeKalb County, Georgia must register and participate in the Federal work authorization program to verify the work eligibility information of new employees. Successful Responder(s) shall be required to register and participate in the Federal work authorization program, which is a part of Attachment I, *Sample County Contract*. Attachment C, *Contractor Affidavit*, should be completed and submitted with the Responder's proposal.

# **IV. CRITERIA FOR EVALUATION**

The following evaluation criteria and the maximum points stated below will be used as the basis for the evaluation of proposals.

- A. Cost Proposal (10 points)
- B. Technical Proposal (80 points):
  - 1. Technical Approach (25 points)
  - 2. Project Management (20 points)
  - 3. Personnel (10 points)
  - 4. Organizational Qualifications (10 points)
  - 5. Financial Responsibility (10 points)
  - 6. References (5 points)
- C. Local Small Business Enterprise Participation (10 points)
- D. Optional Interview (10 points) bonus; The County reserves the right to conduct optional interviews with all Responders or a short-listed group of Responders. The Evaluation Committee may award a maximum of ten (10) points to each interviewed Responder. If the County determines that it is in its best interest to develop a short list of responders for interview, it shall be based on the following calculation: Highest Responder Score 10 points = Short-listed Score (Example: 91 10 = 81. Any Responder with a score of 81 or greater would be interviewed.)

# V. CONTRACT ADMINISTRATION

#### A. Standard County Contract

The attached sample contract is the County's standard contract document (see Attachment I), which specifically outlines the contractual responsibilities. All Responders should thoroughly review the document prior to submitting a proposal. Any proposed revisions to the terms or language of this document must be submitted in writing with the Responder's response to the

request for proposals. Since proposed revisions may result in a proposal being rejected if the revisions are unacceptable to the County, Responders should review any proposed revisions with an officer of the firm having authority to execute the contract. No alterations can be made in the contract after award by the Board of Commissioners.

# **B.** Submittal Instructions

1. One (1) printed original Technical Proposal stamped "Original" with six (6) USB flash drives containing an identical copy of the Technical Proposal ONLY (<u>do not include</u> <u>costs</u>); and one (1) printed original Cost Proposal (see Section III. A. for additional instructions regarding submittal of Cost Proposal), must be submitted to the following address no later than <u>3:00 p.m. on May 14, 2024</u>:

- 2. Proposals must be clearly identified on the outside of the packaging with the Responder's name and "Request for Proposals No. 24-500671 for Zoning Ordinance & Sign Ordinance Update Project" on the outside of the envelope(s) or box(es).
- 3. It is the responsibility of each Responder to ensure that its submission is received by 3:00 p.m. on the proposal due date. The time/date stamp clock located in the Department of Purchasing & Contracting shall serve as the official authority to determine lateness of any response\*. The RFP opening time shall be strictly observed. Be aware that visitors to our offices will go through a security screening process upon entering the building. Responders should plan enough time to ensure that they will be able to deliver their submission prior to our deadline. Late submissions, for whatever reason, will not be evaluated. Responders should plan their deliveries accordingly. Telephone or fax bids will not be accepted. Special Note: While the Maloof Administration Building remains closed to the public during the COVID-19 pandemic, the security desk will accept hand-delivered proposals on behalf of the Department of Purchasing & Contracting. The Responder should request a proposal receipt as verification that the proposal was submitted by the prescribed due date and time.

# C. Pre-Proposal Conference (Non-Mandatory)

A pre-proposal conference will be held at 2:00 p.m. on April 16, 2024, via Zoom video conferencing. Interested responders are strongly encouraged to attend and participate in the pre-proposal conference. # **D.** Questions

All questions concerning this RFP and requests for interpretation of the Contract may be asked and answered during the pre-proposal conference; however, **oral answers are not**  **authoritative**. Questions must be submitted to Kyheem Bristol, via email to <u>kbristol@dekalbcountyga.gov</u> by the <u>5:00 p.m. on April 19, 2024</u>. Questions and requests for interpretation received by the Department of Purchasing and Contracting after this date may not receive a response or be the subject of addenda.

# E. Acknowledgment of Addenda

Addenda may be issued in response to changes in the RFP. It is the responsibility of the Responder to ensure awareness of all addenda issued for this solicitation. Please acknowledge the addenda and submit to the Department of Purchasing and Contracting as requested. Responder may email Kyheem Bristol at kbristol@dekalbcountyga.gov to verify the number of addenda prior to submission. #### F. Proposal Duration

Proposals submitted in response to this RFP must be valid for a period of one hundred fifty (150) days from proposal submission deadline and must be so marked.

#### G. Project Director/Contract Manager

The County will designate a Project Director/Contract Manager to coordinate this project for the County. The successful Responder will perform all work required pursuant to the contract under the direction of and subject to the approval of the designated Project Director/Contract Manager. All issues including, payment issues, shall be submitted to the Project Director/Contract Manager for resolution.

# H. Expenses of Preparing Responses to this RFP

The County accepts no responsibility for any expenses incurred by the Responders to this RFP. Such expenses are to be borne exclusively by the Responders.

# I. Georgia Open Records Act

Without regard to any designation made by the person or entity making a submission, DeKalb County considers all information submitted in response to this invitation or request to be a public record that will be disclosed upon request pursuant to the Georgia Open Records Act, O.C.G.A. §50-18-70 <u>et seq</u>., without consulting or contacting the person or entity making the submission, unless a court order is presented with the submission. You may wish to consult an attorney or obtain legal advice prior to making a submission.

#### J. First Source Jobs Ordinance

The First Source Ordinance is a public regulation which requires contractors and beneficiaries of eligible DeKalb County projects to make a good faith effort to hire fifty (50) percent of all jobs using the First Source Registry. Beneficiaries are immediate recipients of county grants or community development block funds administered by the county of at least \$50,000.

Contractors include an individual or entity entering into any type of agreement with the county, funded in whole or in part with county funds. WorkSource DeKalb (WSD) maintains the First Source Registry, comprised of qualified and trained DeKalb County residents. Business Solutions Unit (BSU) is available to assist the employer with selecting the most qualified candidate by using the First Source Registry to meet the company's hiring needs. WSD manages the First Source program through the Business Solutions Unit by assigning a specific BSU Specialist. The First Source process is conducted similarly to the BSU business service request process. The BSU Specialist works closely with employers using TALEO and BSU processes to ensure the hiring needs of the employers are met.

#### K. Business License

Responder shall submit a copy of its current, valid business license with its proposal or upon award. If the Responder is a Georgia corporation, Responder shall submit a valid county or city business license. If the Responder is not a Georgia corporation, Responder shall submit a certificate of authority to transact business in the state of Georgia and a copy of its valid business license issued by its home jurisdiction. If Responder holds a professional certification which is licensed by the state of Georgia, then Responder shall submit a copy of its valid professional license. Any license submitted in response to this requirement shall be maintained by the Responder for the duration of the contract.

#### L. Ethics Rules

Bidders are subject to the Ethics provision within the DeKalb County Purchasing Policy; the Organizational Act, Section 22A, the Code of DeKalb County; and the rules of Executive Order 2014-4. Any violations will be addressed, pursuant to these policies and rules.

To the extent that the Organizational Act, Section 22A, the Code of DeKalb County, and the rules of Executive Order 2014-4 allow a gift, meal, travel expense, ticket, or anything else of value to be purchased for a CEO employee by a contractor doing business with the County, the contractor must provide written disclosure, quarterly, of the exact nature and value of the purchase to the Chief Integrity Officer, if created, or the Finance Director or his/her designee. Every contractor conducting business with the County will receive a copy of these ethical rules at the time of execution of the contract.

# M. Right to Audit

The County shall have the right to audit all books and records, including electronic records, relating or pertaining to this contract or agreement, including but not limited to all financial and performance related records, property, and equipment purchased in whole or in part with County funds and any documents or materials which support those records, kept under the control of the Contractor, including but not limited to those kept by the Contractor's employees, agents, assigns, successors and subcontractors. The County also has the right to communicate with Contractor's employees related to the audited records.

The Contractor shall maintain such books and records, together with such supporting or underlying documents and materials, for the duration of this contract and for seven (7) years after termination or expiration, including any and all renewals thereof. The books and records, together with supporting documents and materials shall be made available, upon request to the County or its designee, during normal business hours at the Contractor's office or place of business. In the event that no such location is available, then the books, records, and supporting documents shall be made available for audit at a time and location which is convenient for the County.

DeKalb County assures every effort will be made to ensure nondiscrimination in all of its programs and activities, whether those programs and activities are federally funded or not. In addition, DeKalb County will take reasonable steps to provide meaningful access to services for persons with Limited English Proficiency (LEP).

#### N. Cooperative Agreement

The County through the Department of Purchasing and Contracting may permit piggybacks to this contract from other city, county, local authority, agency, or board of education if the vendor will extend the same prices, terms, and conditions to the city. Piggybacking shall only be available where competition was used to secure the contract and only for a period of 12-months following entry, renewal or extension of the contract. This provision shall not apply to any contract where otherwise prohibited or mandated by state law.

# VI. AWARD OF CONTRACT

- A. An evaluation committee will review and rate all proposals and shall determine if interviews are necessary.
- B. If interviews are conducted, firms will be scheduled for an oral presentation to the evaluation committee, not to exceed one hour's duration, to respond to questions from the evaluation committee relevant to the firm's proposal.
- C. The evaluation committee will make its recommendation for award to the DeKalb County Board of Commissioners, who will make the final decision as to award of contract.

# THE COUNTY RESERVES THE RIGHT TO REJECT ANY AND ALL PROPOSALS, TO WAIVE INFORMALITIES, AND TO RE-ADVERTISE.

# **SCOPE OF WORK**

# A. <u>Goals and Objectives (including, but not limited to):</u>

# 1. **Zoning Ordinance**

- a. Build on the goals and action items from the 2050 Unified Plan including implementation of small area plans
- Refinement, deletion, or update of existing zoning districts especially the RNC (Residential Neighborhood Conservation) Zoning District and the Mixed-Use zoning districts
- c. Creation of overlay or special purpose districts, as necessary, and consideration of planned development zoning district(s) and residential office zoning district(s)
- d. Inclusion of helpful illustrations, tips, and reminders throughout the document
- e. Revision of the Use Table including, but not limited to-addition of common contemporary uses; deletion of antiquated uses; color-coding; and rearranging of categories.
- f. Simplifying and alphabetizing supplemental regulations
- g. Revise/update zoning district development standards tables
- h. Streamline community and building design standards
- i. Update parking standards, including reductions where appropriate
- j. Elimination of administrative waivers and lot merger provisions
- k. Introduction of economic development and housing (including senior housing) zoning incentives

# 2. Sign Ordinance

- a. Build on the goals and action items from the 2050 Unified Plan
- b. Establish signage as a design element that can contribute to a sense of place/gateways
- c. Encourage more pedestrian oriented signage
- d. Reduce the prominence of signage while balancing commercial and aesthetic interests
- e. Make regulations more user friendly and easier to interpret
- f. Create specific illustrations and detailed drawings, where appropriate
- g. Create a temporary sign program to assist small businesses and special events
- h. Address monuments, public art and murals
- i. When applicable, streamline regulations

# B. <u>Project Tasks:</u>

# 1. Task One - Public Involvement

The goal of this task is to develop an outreach and engagement process that promotes the involvement of as many stakeholders as possible with special consideration to include low to moderate income, minority populations, millennials, students, landowners, business owners, elderly and disabled residents. The Consultant will identify stakeholders and facilitate their involvement in the planning process. The Consultant shall produce a Public Participation Plan, to outline the public input strategy for this project. It is anticipated that the process shall include 80-100 public input meetings of various sizes. These may be held in traditional (e.g., public workshop) and nontraditional locations (e.g., commercial venue) and/or formats (e.g., handout flyers, on-street surveys, online polling, etc.) A schedule of meetings and locations(s) shall be made available within a reasonable time from the onset of the project: community engagement, charette, workshop sessions, and/or public meetings (including, but not limited to: "kick-off" period, ten (10) Community Council meetings [virtual], five (5) Planning Commission meetings [virtual], and ten (10) Board of Commissioners meeting [in-person]). The variety of meeting types will address the requirements and allow for public input during the planning process. Additionally, the number of meetings allows for input over time to address any concerns or to allow time for the public to bring collective goals. The public involvement process shall, at a minimum, include the following components:

- a. **Kick-off period (in-person):** to announce the beginning of the process, project goals, project timeline, key dates, preliminary findings from text review of the existing *Ordinance*, and opportunities for public input at a Board of Commissioners meeting along with internal staff workshop day(s).
- b. **Data gathering/outreach/engagement meetings (virtual and/or in-person):** to collect, synthesize, and display data, information, and opinions from the public on pertinent topics. These meetings can also be used to review preliminary findings and general directions.
- c. **Design Charrette (in-person):** to identify and validate desired architectural and site design elements for the area.
- d. **Community Council Meetings (virtual):** Periodic drafts shall be presented to the five community councils and the public for review and comment prior to finalizing the updates.
- e. **Planning Commission Meetings (virtual):** Periodic drafts and concepts shall be presented to Planning Commission and the public for review and comment prior to finalizing the updates.
- f. Board of Commissioners—Planning, Economic Development, Community Services (PECS) Committee (in-person): Periodic progress updates and discussions of concepts needing policy direction shall be presented to Planning Commission and the public for review and comment prior to finalizing the updates.
- g. **Board of Commissioners (in-person):** Periodic progress updates, presentation of draft documents to the legislative body, and delivery of final draft documents for adoption.
- h. Workshops (virtual and/or in-person): Technical sessions to deep dive into specific concepts, terms, or details. These sessions should seek to educate members of the public as well as inform and obtain input. Technical sessions will provide an

in-depth knowledge of the specific learning components related to educational goals and objectives of the planned project.

i. **Community tour, if needed (in-person):** County staff will lead a community tour with the Consultant to highlight key features, communities, sites, landmarks, boundaries, geography, and other places of interest. A tour provides the consulting team with valuable context to the issues that are discussed over the course of the kick-off period. The Consultant will also use the tour to begin compilation of a photo inventory for future use.

These tasks will be documented through meeting notices, meeting summaries, and other written communications, and when possible, video recording. Responses and acknowledgement of public comments must be documented. The public involvement process should include a variety of methods, times, and techniques to reach the broadest range of stakeholders possible.

# 2. Task Two - Project Management

The purpose of Task Two is to ensure that the project begins with a clear understanding of the project's processes, schedule, and desired outcomes. Task Two outlines the working relationship among County staff, the Consultant, the Project Management Team, and a Stakeholder Committee.

The Consultant will perform an evaluation of the existing zoning regulations that will serve as the baseline upon which proposed changes will be made. The "kick-off" period will serve as a means of collecting information and building relationships between the consulting team and the County. Involvement from various DeKalb County departments, appointed officials, and/or elected officials is imperative to a successful planning process. It will be expected to have continual and ongoing communications with County Staff. Interactions with staff will include regularly scheduled phone and email communications between the Consultant and the County staff project manager. Over the course of the project, the consultant will be expected to attend, present, and participate in at least forty (40) community engagement, charette, workshop sessions, and/or public meetings (including, but not limited to: "kick-off" period, ten (10) Community Council meetings [virtual], five (5) Planning Commission meetings [virtual], and ten (10) Board of Commissioners meeting [in-person]).

Current Planning staff and the Consultant shall create a Project Management Team. This team shall meet at least monthly to discuss the project's progress. The key responsibilities of the Project Management Team are to manage the project, set objectives and milestones, review and comment on materials to be presented at public meetings, and distribute information to community participants.

A Project Management Plan (PMP) shall be developed indicating dates for work task milestones, project timeline, receipt of deliverables and key decision-making points. The PMP will drive the work schedule for the duration of the project; therefore, it is critical that the plan provides an overview of the process, project goals, key dates, opportunities for

public input, review of preliminary findings, and concepts of deliverables. The dedicated website for updates, data, document drafts, and other pertinent project information will be available at https://engagedekalb.dekalbcountyga.gov.

It is also expected that County Staff will periodically provide updates to various boards and commissions at their regular meetings to keep them apprised of the process and from time to time seek feedback on a particular topic or question. Staff will also facilitate connections between the Consultant and community stakeholders. Staff shall provide the necessary zoning information, background information, interpretations, and other documents related to the project. Information to be supplied includes but is not limited to:

- a. 2050 DeKalb County Unified Plan
- b. DeKalb Municipalities' comprehensive plans
- c. Strategic Economic Development Plans broadband accessibility plans, and housing plans (to the extent they exist and are relevant)
- d. Solid Waste Management Plans (landfill) and Watershed Mgmt. Plans
- e. The Atlanta Region's Plan Policy Framework Modal studies conducted by agencies within the study area
- f. Livable Centers Initiative (LCI) plans, Master Active Living Plans, corridor studies, and other active small area plans
- g. County Board of Education facilities planning documents
- h. I-20 East TOD Study Initiative
- i. Police Department planning initiatives
- j. Airport Master Plan, if applicable
- k. Parks & Recreation Master Plan
- 1. Memorial Drive Redevelopment Plan
- m. MARTA TOD Guidelines and other pertinent info
- n. Zoning Ordinance, Sign Ordinance, subdivision regulations, and any other land use controls used to implement the Comprehensive Plan.
- o. Sustainability Plan

The project shall also include a Stakeholder Committee. This committee shall include three (3) members of the County Development Oversight Committee, one (1) member from each community council, one (1) Planning Commission member, and three (3) members chosen by the Current Planning Manager for a total of twelve (12) committee members. The committee will serve in a technical advisory capacity to assess zoning proposals and concepts.

# 3. Task Three - Project Deliverables

This task requires the Consultant to generate a variety of documents at various milestones of the project process. The summary planning document for the corridor study shall contain at a minimum the following:

- a. **Ordinance Assessments**: Evaluations of both documents shall be conducted by the Consultant to establish strengths, weaknesses, and opportunities to improve land use and sign regulations.
- b. **Project Management Plan**: an overview of the process, project goals, key dates, opportunities for public input, review of preliminary findings, and concepts of deliverables.
- c. **Public Participation Plan**: public participation process used to achieve a community-supported project outcome.
- d. **Executive Summary**. A synopsis of the project, process, findings, and solutions provided in the ordinance documents.
- e. **Zoning Ordinance**: Revised (digital) ordinance document with updated regulations, illustrations, and other content.

- f. **Sign Ordinance**: Revised (digital) ordinance document with updated regulations, illustrations, maps, and other content.

Certified Local Small Business Enterprises (LSBEs) located within DeKalb County and prime contractors utilizing LSBEs that are locally-based inside DeKalb County shall receive ten (10) points in the initial evaluation of their response to any Request for Proposal. ### AGREEMENT FOR PROFESSIONAL SERVICES

## **DEKALB COUNTY, GEORGIA**

THIS AGREEMENT made as of this \_\_\_\_\_day of \_\_\_\_, 20\_\_\_, (hereinafter called the "execution date") by and between DEKALB COUNTY, a political subdivision of the State of Georgia (hereinafter referred to as the "County"), and \_\_\_\_\_\_, a corporation organized and existing under the laws of the State of \_\_\_\_\_, with offices in \_\_\_\_\_\_, (hereinafter referred to as "Contractor"), shall constitute the terms and conditions under which the Contractor shall provide \_\_\_\_\_\_ in DeKalb County, Georgia.

WITNESSETH: That for and in consideration of the mutual covenants and agreements herein set forth, the County and the Contractor hereby agree as follows:

## <u>ARTICLE I. CONTRACT TIME & TERM</u>

The Contractor shall commence the Work under this Contract within ten (10) days from acknowledgment of receipt of a written Notice to Proceed ("Commencement Date"). The Initial Term of this Agreement shall be for twelve (12) calendar months, beginning on the Commencement Date. This is an annual contract with three (3) options to renew. Prior to the expiration of the Initial Term, the parties have the option to renew this agreement for a first annual Renewal Term of twelve (12) calendar months. Prior to the expiration of the first annual Renewal Term, the parties have the option to renew this Agreement for a second annual Renewal Term of twelve (12) calendar months. Prior to the expiration of the second annual Renewal Term, the parties have the option to renew this Agreement for a third annual Renewal Term of twelve (12) calendar months. Without further action by either party, this Agreement will terminate at the end of the Initial Term or at the end of each annual Renewal Term and, is only effective upon adoption and approval by the DeKalb County Governing Authority and the Contractor in accordance with the terms of this Contract.

### ARTICLE II. PAYMENT

As full payment for the faithful performance of this Contract, the County shall pay the Contractor, the Contract Price, which is an amount not to exceed (\$ ), unless changed by written Change Order in accordance with the terms of this Contract. The term "Change Order" includes the term "amendment" and shall mean a written order authorizing a change in the Work, and an adjustment in Contract Price to Contractor or the Contract Term, as adopted and approved by the Contractor and the DeKalb County Governing Authority, or the Chief Executive Officer, if exempted from Governing Authority adoption and approval in accordance with the express terms of this Contract. The Chief Executive Officer or his/her designee shall have the authority to approve and execute a Change Order lowering the Contract Price or increasing the Contract Price up to twenty percent (20%) of the original Contract Price, provided that the total amount of the increase authorized by such Change Order is less than \$100,000.00. If the original Contract or Purchase Order Price does not exceed \$100,000.00, but the Change Order will make the total Contract Price exceed \$100,000.00, then the Change Order will require approval by official action of the Governing Authority. Any other increase of the Contract Price shall be by Change Order adopted and approved by the DeKalb County Governing Authority and the Contractor in accordance with the terms of this Contract. Amounts paid to the Contractor shall comply with and not exceed Attachment B, the Contractor's Cost Proposal, consisting of page(s) attached hereto and incorporated herein by reference. Payment is to be made no later than thirty (30) days after submittal of undisputed invoice.

B. Upon award, Prime Contractor(s) with Local Small Business Enterprise (LSBE)Subcontractor(s) shall enter utilization reports electronically at <u>www.dekalblsbe.info</u>. Proof of payment to the LSBE Subcontractor must be uploaded and submitted. LSBE Subcontractors shall confirm receipt of payment from the Prime, electronically also, at <u>www.dekalblsbe.info</u>

## **ARTICLE III. SCOPE OF WORK**

The Contractor agrees to provide all \_\_\_\_\_\_\_ services in accordance with, Attachment A, Scope of Work attached hereto and incorporated herein by reference, the County's Request for Proposals (RFP) No. No. 24-500671 for Zoning Ordinance & Sign Ordinance Update Project, attached hereto as Appendix I and incorporated herein by reference, and the Contractor's response thereto, attached hereto as Appendix II and incorporated herein by reference.

The Contractor's services shall include all things, personnel, and materials necessary to accomplish specific projects authorized by the County.

## **ARTICLE IV. GENERAL CONDITIONS**

A. <u>Accuracy of Work</u> The Contractor shall be responsible for the accuracy of the Work and any error and/or omission made by the Contractor in any phase of the Work under this Agreement.

B. <u>Additional Work</u> The County shall in no way be held liable for any work performed under this section which has not first been approved in writing by the County in the manner required by applicable law and/or the terms of this Contract. The County may at any time order changes within the scope of the Work without invalidating the Contract upon seven (7) days written notice to the Contractor. The Contractor shall proceed with the performance of any changes in the Work so ordered by the County unless such change entitles the Contractor to a change in Contract Price, and/or Contract Term, in which event the Contractor shall give the County written notice thereof within fifteen (15) days after the receipt of the ordered change, and the Contractor shall not execute such changes until it receives an executed Change Order from the County. No extra cost or extension of time shall be allowed unless approved by the County and authorized by execution of a Change Order. The parties' execution of any Change Order constitutes a final settlement of all matters relating to the change in the Work which is the subject of the Change Order. The County shall not be liable for payment for any work performed under this section which has not first been approved in writing by the County in the manner required by applicable law and/or the terms of this Contract.

C. <u>Ownership of Documents</u> All documents, including drawings, estimates, specifications, and data are and remain the property of the County. The Contractor agrees that the County may reuse any

and all plans, specifications, drawings, estimates, or any other data or documents described herein in its sole discretion without first obtaining permission of the Contractor and without any payment of any monies to the Contractor therefore. However, any reuse of the documents by the County on a different site shall be at its risk and the Contractor shall have no liability where such documents are reused.

D. <u>Right to Audit</u> The County shall have the right to audit all books and records, including electronic records, relating or pertaining to this contract or agreement, including but not limited to all financial and performance related records, property, and equipment purchased in whole or in part with County funds and any documents or materials which support those records, kept under the control of the Contractor, including but not limited to those kept by the Contractor's employees, agents, assigns, successors and subcontractors. The County also has the right to communicate with Contractor's employees related to the audited records.

The Contractor shall maintain such books and records, together with such supporting or underlying documents and materials, for the duration of this contract and for seven (7) years after termination or expiration, including any and all renewals thereof. The books and records, together with supporting documents and materials shall be made available, upon request to the County or its designee, during normal business hours at the Contractor's office or place of business. In the event that no such location is available, then the books, records, and supporting documents shall be made available for audit at a time and location which is convenient for the County.

E. <u>Successors and Assigns</u> The Contractor agrees it shall not sublet, assign, transfer, pledge, convey, sell, or otherwise dispose of the whole or any part of this Contract or his/her right, title, or interest therein to any person, firm, or corporation without the previous written consent of the County. If the County consents to any such assignment or transfer, then the Contractor binds itself, its partners, successors and assigns to all covenants of this Contract. Nothing contained in this Contract shall create, nor be interpreted to create privity, or any other relationship whatsoever, between the County and any person, or entity or than Contractor.

F. <u>Reviews and Acceptance</u> Work performed by the Contractor shall be subject to review and acceptance in stages as required by the County. Acceptance shall not relieve the Contractor of its professional obligation to correct, at his/her own expense, any errors in the Work.

G. Termination of Agreement The Contractor understands and agrees that the date of the beginning of Work, rate of progress, and time for completion of the Work are essential conditions of this Contract. The County may, for its own convenience and at its sole option, without cause and without prejudice to any other right or remedy of County, elect to terminate the Contract by delivering to the Contractor, at the address listed in the Notices article of this Contract, a written notice of termination specifying the effective date of termination. Such notice shall be delivered to Contractor at least thirty (30) days prior to the effective date of termination. If Contractor's services are terminated by the County, the termination will not affect any rights or remedies of the County then existing or which may thereafter accrue against Contractor or its surety. In case of termination of this Contract before completion of the Work, Contractor will be paid only for the portion of the Work satisfactorily performed through the effective date of termination as determined by the County. Neither party shall be entitled to recover lost profits, special, consequential or punitive damages, attorney's fees or costs from the other party to this Contract for any reason whatsoever. This Contract shall not be deemed to provide any third-party with any remedy, claim, right of action, or other right. The parties' obligations pursuant to this Section shall survive any acceptance of Work, or termination or expiration of this Contract.

H. <u>Indemnification Agreement</u> The Contractor shall be responsible from the execution date or from the time of the beginning of the Work, whichever shall be the earlier, for all injury or damage of any kind resulting from the Work, to persons or property, including employees and property of the County. The Contractor shall exonerate, indemnify, and save harmless the County, its elected officials, officers, employees, agents and servants, hereinafter collectively referred to in this Section as "the County Indemnitees," from and against all claims or actions based upon or arising out of any damage or injury (including without limitation any injury or death to persons and any damage to property) caused by or sustained in connection with the performance of this Contract or by conditions created thereby or arising out of or any way connected with Work performed under this Contract, as well as all expenses incidental to the defense of any such claims, litigation, and actions. Furthermore, Contractor shall assume and pay for, without cost to the County Indemnitees, the defense of any and

all claims, litigation, and actions suffered through any act or omission of the Contractor, or any Subcontractor, or anyone directly or indirectly employed by or under the supervision of any of them. Notwithstanding any language or provision in this Contract, Contractor shall not be required to indemnify any County Indemnitee against claims, actions, or expenses based upon or arising out of the County Indemnitee's sole negligence. As between the County Indemnitees and the Contractor as the other party, the Contractor shall assume responsibility and liability for any damage, loss, or injury, including death, of any kind or nature whatever to person or property, resulting from any kind of claim made by Contractor's employees, agents, vendors, Suppliers or Subcontractors caused by or resulting from the performance of Work under this Contract, or caused by or resulting from any error, omission, or the negligent or intentional act of the Contractor, vendors, Suppliers, or Subcontractors, or any of their officers, agents, servants, or employees. The Contractor shall defend, indemnify, and hold harmless the County Indemnitees from and against any and all claims, loss, damage, charge, or expense to which they or any of them may be put or subjected by reason of any such damage, loss, or injury. The Contractor expressly agrees to provide a full and complete defense against any claims brought or actions filed against the County Indemnitees, where such claim or action involves, in whole or in part, the subject of the indemnity contained in this Contract, whether such claims or actions are rightfully or wrongfully brought or filed. The County has the sole discretion to choose the counsel who will provide the defense. No provision of this Contract and nothing herein shall be construed as creating any individual or personal liability on the part of any elected official, officer, employee, agent or servant of the County, nor shall the Contract be construed as giving any rights or benefits hereunder to anyone other than the parties to this Contract. The parties' obligations pursuant to this Section shall survive any acceptance of Work, or termination or expiration of this Contract.

I. **Insurance** Prior to commencing work, Contractor shall, at its sole expense, procure and maintain insurance of the types and in the amounts described below from insurer(s) authorized to transact business in the state where the work or operations will be performed by Contractor. Such insurance shall be placed with admitted insurers that maintain an A.M. Best's rating of not less than "A" (Excellent) with a Financial Size Category of VII or better with coverage forms acceptable to Contractor. The insurance described below shall be maintained uninterrupted for the duration of the project, including any warranty periods, and shall protect Contractor, and others as required by contract, for liabilities in connection with work performed by or on behalf of Contractor, its agents, representatives, employees or Contractors.

- 1. Certificates of Insurance in companies doing business in Georgia and acceptable to the County covering:
  - Statutory Workers' Compensation Insurance, or proof that Contractor is not (a) required to provide such coverage under State law;
    - (1) Employer's liability insurance by accident, each accident \$1,000,000
    - (2) Employer's liability insurance by disease, policy limit \$1,000,000
    - (3) Employer's liability insurance by disease, each employee \$1,000,000
  - Professional Liability Insurance on the Contractor's services in this Agreement (b) with limit of \$1,000,000;
  - Commercial General Liability Insurance covering all operations with (c) combined single limit of \$1,000,000;
  - Comprehensive Automobile Liability Insurance with form coverage for all (d) owned, non-owned and hired vehicles with combined single limit of \$1,000,000.
  - Umbrella or Excess Insurance. Umbrella or excess insurance is to be provided (e) with General Liability, Auto Liability and Employers Liability scheduled as underlying policies with limits not less than the following: \$5,000,000 per occurrence \$5,000,000 aggregate
- 2. Additional Insured Requirement:
  - The County, its elected officials, officers, employees and agents, hereinafter (a) referred to in this article and in the article entitled "Certificates of Insurance" as "the County and its officers" are to be named as additional insured on all policies of insurance except worker's compensation insurance with no cross

suits exclusion. The County and its officers shall be included as additional insureds under commercial general liability and commercial umbrella insurance, for liabilities arising out of both the ongoing and completed operations of Contractor. Such additional insured coverage shall be endorsed to Contractor's policy by attachment of ISO Additional Insured Endorsement forms CG 20 10 10 01 (ongoing operations) and CG 20 37 10 01 (products-completed operations), or form(s) providing equivalent coverage.

- (b) All coverages required of the Contractor will be primary over any insurance or self-insurance program carried by the County.
- (c) If the Contractor is a joint venture involving two (2) or more entities, then each independent entity will satisfy the limits and coverages specified here or the joint venture will be a named insured under each respective policy specified.
- 3. Fidelity Bond coverage shall be provided. Coverage limits shall not be less than the amount scheduled in the contract.
- 4. Certificates of Insurance must be executed in accordance with the following provisions:
  - (a) Certificates to contain policy number, policy limits, and policy expiration date of all policies issued in accordance with this Agreement;
  - (b) Certificates to contain the location and operations to which the insurance applies;
  - (c) Certificates to contain Contractor's protective coverage for any subcontractor's operations;
  - (d) Certificates to contain Contractor's contractual liability insurance coverage;
  - (e) Certificates are to be **<u>issued</u>** to:

- 5. The Contractor shall be wholly responsible for securing certificates of insurance coverage as set forth above from all subcontractors who are engaged in this work.
- 6. The Contractor agrees to carry statutory Workers' Compensation Insurance and to have all subcontractors likewise carry statutory Workers' Compensation Insurance.
- 7. Contractor agrees to waive all rights of subrogation and other rights of recovery against the County and its officers and shall cause each Subcontractor to waive all rights of subrogation for all coverage, excluding Professional E&O.
- 8. Failure of the County to demand such certificate or other evidence of full compliance with these insurance requirements or failure of the County to identify a deficiency from evidence provided will not be construed as a waiver of the Contractor's obligation to maintain such coverage. Contractor understands and agrees that the purchase of insurance in no way limits the liability of the Contractor.
- 9. Certificates shall state that the policy or policies shall not expire, be cancelled or altered without at least sixty (60) days prior written notice to the County. Policies and Certificates of Insurance listing the County and its officers as additional insureds (except for workers' compensation insurance) shall conform to all terms and conditions (including coverage of the indemnification and hold harmless agreement) contained in this Contract.
- 10. If the County shall so request, the Contractor will furnish the County for its inspection and approval such policies of insurance with all endorsements, or confirmed specimens thereof certified by the insurance company to be true and correct copies. Contractor shall be responsible and have the financial wherewithal to cover any deductibles or retentions included on the certificate of insurance.

J. <u>Georgia Laws Govern</u> The laws of the State of Georgia shall govern the construction of this Contract without regard for conflicts of laws. Should any provision of this Contract require judicial interpretation, it is agreed that the court interpreting or construing the same shall not apply a

presumption that the terms hereof shall be more strictly construed against one party, by reason of the rule of construction, that a document is to be construed more strictly against the party who itself or through its agent prepared same; it being agreed that the agents of all parties have participated in the preparation hereof, and all parties have had an adequate opportunity to consult with legal counsel. In interpreting this Contract in its entirety, the printed provisions of this Contract, and any additions written or typed hereon, shall be given equal weight, and there shall be no inference by operation of law or otherwise; that any provision of this Contract shall be construed against either party hereto.

K. <u>Venue</u> This Agreement shall be deemed to have been made and performed in DeKalb County, Georgia. For the purposes of venue, all suits or causes of action arising out of this Agreement shall be brought in the courts of DeKalb County, Georgia.

L. Contractor and Subcontractor Evidence of Compliance; Federal Work Authorization Pursuant to O.C.G.A. §13-10-91, the County cannot enter into a contract for the physical performance of services unless the Contractor, its Subcontractor(s) and sub-subcontractor(s), as that term is defined by state law, register and participate in the Federal Work Authorization Program to verify specific information on all new employees. Contractor certifies that it has complied and will continue to comply throughout the Contract Term with O.C.G.A. §13-10-91 and any related and applicable Georgia Department of Labor Rule. Contractor agrees to sign an affidavit evidencing its compliance with O.C.G.A. §13-10-91. The signed affidavit is attached to this Contract as Attachment D. Contractor agrees that in the event it employs or contracts with any Subcontractor(s) in connection with this Contract, Contractor will secure from each Subcontractor an affidavit that certifies the Subcontractor's current and continuing compliance with O.C.G.A. §13-10-91 throughout the Contract Term. Any signed Subcontractor affidavit(s) obtained in connection with this Contract shall be attached hereto as Attachment E. Each Subcontractor agrees that in the event it employs or contracts with any sub-subcontractor(s), each Subcontractor will secure from each sub-subcontractor an affidavit that certifies the sub-subcontractor's current and continuing compliance with O.C.G.A. §13-10-91 throughout the Contract Term. Any signed sub-subcontractor affidavit(s) obtained in connection with this Contract shall be attached hereto as Attachment F.

M. <u>County Representative</u> The County may designate a representative through whom the Contractor will contact the County. In the event of such designation, said representative shall be consulted and his/her written recommendation obtained before any request for extra work is presented to the County. Payments to the Contractor shall be made only upon itemized bill submitted to and approved by said representative.

N. <u>Contractor's Status</u> The Contractor will supervise and direct the Work, including the Work of all Subcontractors. Only persons skilled in the type of work which they are to perform shall be employed. The Contractor shall, at all times, maintain discipline and good order among his/her employees, and shall not employ any unfit person or persons or anyone unskilled in the work assigned him/her. The relationship between the County and the Contractor shall be that of owner and independent contractor. Other than the consideration set forth herein, the Contractor, its officers, agents, servants, employees, and any Subcontractors shall not be entitled to any County employee benefits including, but not limited to social security, insurance, paid annual leave, sick leave, worker's compensation, free parking or retirement benefits. All services provided by Contractor shall be by employees of Contractor or any Subcontractor shall be deemed an officer or employee of the County. Personnel policies, tax responsibilities, social security payments, health insurance, employee benefits and other administrative policies, procedures or requirements applicable to the Work or services rendered under this Contract shall be those of the Contractor, not the County.

O. <u>Georgia Open Records Act</u> Contractor shall comply with the applicable provisions of the Georgia Open Records Act, O.C.G.A. §50-18-70 *et seq*.

P. <u>First Source Jobs Ordinance and Preferred Employees</u> The Contractor is required to comply with the DeKalb County First Source Jobs Ordinance, Code of DeKalb County as Revised 1988, section 2-231 *et seq.*, and among other things, is required to make a good faith effort to hire DeKalb County residents for at least fifty percent 50% of all jobs created by an Eligible Project, as that term is defined in the First Source Ordinance, using the First Source Registry. Contractors, subcontractors, and independent contractors bidding on this contract will be encouraged by DeKalb County to have 25% or more of their labor forces for this project consist of Preferred Employees selected from the

First Source Registry. The First Source Registry has Preferred Employees trained by U.S. Department of Labor registered apprenticeship programs and other partners. Q. **Business License** Contractor shall submit a copy of its current, valid business license with this Contract. If the Contractor is a Georgia corporation, Contractor shall submit a valid county or city business license. If Contractor is a joint venture, Contractor shall submit valid business licenses for each member of the joint venture. If the Contractor is not a Georgia corporation, Contractor shall submit a certificate of authority to transact business in the state of Georgia and a copy of its current, valid business license issued by its home jurisdiction. If Contractor holds a professional license, then Contractor shall submit a copy of the valid professional license. Failure to provide the business license, certificate of authority, or professional license required by this section, may result in the Contract being terminated. Contractor shall ensure that any insurance, license, permit or certificate submitted in response to the County's RFP or as part of the Contract shall be current and valid when submitted, and shall remain valid, current and maintained in good standing for the Contract Term.

R. <u>Sole Agreement</u> This Contract constitutes the sole contract between the County and the Contractor. The terms, conditions, and requirements of this Contract may not be modified, except by Change Order. No verbal agreement or conversation with any officer, agent, or employee of the County, either before or after the execution of the Contract, shall affect or modify any of the terms or obligations herein contained. No representations, oral or written, shall be binding on the parties unless expressly incorporated herein. No Change Order shall be enforceable unless approved by official action of the County as provided by law or in this Contract.

S. <u>Attachments and Appendices</u> This Contract includes the following Attachments and Appendices all of which are incorporated herein by reference: Attachment A, Scope of Work, Attachment B, Contractor's Cost Proposal; Attachment D, Contractor's Affidavit; Attachment E, Subcontractor's Affidavit(s); Attachment G, Certificate of Corporate Authority, Articles of Organization, or Joint Venture Certificate; Attachment H, Required Documents; Appendix I, County's RFP; and Appendix II, Contractor's Response.

T. <u>Severability</u> If any provision of this Contract or the application thereof to any person or circumstance shall to any extent be held invalid, then the remainder of this Contract or the application of such provision to persons or circumstances, other than those as to which it is held invalid, shall not be affected thereby, and each provision of this Contract shall be valid and enforced to the fullest extent permitted by law.

U. <u>Notices</u> Any notice or consent required to be given by or on behalf of any party hereto to any other party hereto shall be in writing and shall be sent to the County's Chief Executive Officer and the Executive Assistant or to the Contractor or his/her authorized representative on the work site by (a) registered or certified United States mail, return receipt requested, postage prepaid, (b) personal delivery, or (c) overnight courier service. All notices sent to the addresses listed below shall be binding unless said address is changed in writing no less than fourteen days before such notice is sent. Future changes in address shall be effective upon written notice being given by the Contractor to the County's Executive Assistant or by the County to the Contractor's authorized representative via certified first-class U.S. mail, return receipt requested.
