SUBJECT: **Comprehensive Revenue Study Report**

DATE: September 28, 2009

Finance Department's Division of Internal Audit conducts compliance and operational audits as well as reviews and special projects requested by upper management. Per your request, Internal Audit has completed a countywide revenue study.

Internal Audit collected fee information from various departments, but presented only those that indicated a willingness to increase fees at this time based on their justification or evaluation. It should be pointed out that, a few months ago, Internal Audit analyzed, held discussions and received indications from the departments that they would consider increasing fees and charges.

The results of the revenue study disclose user fees/charges and a new business occupation tax for retail liquor package stores based on a profitability ratio presented in this report. It should be pointed out that County Code Chapter 15 - Licenses, Permits and Miscellaneous Business Regulations would need to be amended to include the business occupation tax, since it is not covered in the existing code.

Internal Audit would like to extend appreciation to all departments that participated in this study.

EXECUTIVE SUMMARY

The following is a summary of recommended fee increases submitted by the various departments:

- Finance Business License: The recommendation is to charge retail package liquor stores a general business occupation tax in addition to their license fee. **The projected additional** revenue is \$ 131,000.
- Fire Rescue Services The recommendation is to increase Base Rates, Mileage Fee, and fees related to medical services provided. **The projected additional revenue is \$ 1,200,000**.
- Human Development The recommendation is to increase fees for Senior Center membership, rentals, cafeteria and leases. The projected additional revenue is \$ 119,000.
- Parks and Recreation The recommendation is to increase fees at the Mystery Valley and Sugar Creek Golf Courses. **The projected additional revenue is \$ 340,000.**
- Planning and Development The recommendation is to increase fees for sign permits, zoning, and re-submittals of documents for commercial building permits and to initiate fees for State Water Determination and Arborist Tree Assessments. Due to the current economic situation and uncertainty of development projections, no projections were made for several of these increases, but a partial projection of additional revenue is \$ 241,000.
- Police Services The recommendation is to change the pricing structure of False Alarm billings, to add a Surrender Charge for Animal Control, increase various fees for background checks and permits, and to charge 911 fees for those who use the VOIP-internet phone format. The **projected additional revenue is \$ 430,000.**
- Public Works Transportation: The recommendation is to increase the prices of Hang Tags and Parking Decals and create a Utility Encroachment Permit. The projected additional revenue is \$ 39,000.
- Tax Assessors The recommendation is to increase the cost of the Complete Tax Digest to \$ 100. The projected additional revenue is \$ 2,000.

Conclusion

The total projected additional revenue from the above recommendations is **\$ 2,502,000** with no projections made for several of the fee increases due to the uncertainty of the volume of activities and transactions that are controlled by the economy.

PURPOSE, SCOPE AND METHODOLOGY

Purpose and Scope

The following were the primary objectives:

- Obtain recommendations from each Department for user fee increases and their projected increase of total revenue.
- Summarize recommended fee increases and projected additional revenue.

Methodology

The following DeKalb County Departments were included in this study:

- Finance
- Fire Rescue Services
- Human Development
- Parks and Recreation
- Planning and Development
- Police Services
- Public Works
- Tax Assessors

Internal Audit compiled and summarized responses given by the above listed Departments. Some Departments had no recommendations, had recently increased fees, or have fees regulated by the State of Georgia. Details of recommendations and projected additional revenues, by Department, follow:

Comments

DeKalb County charges retail liquor package store establishments a flat fee (\$4,900) for an alcohol license.

Fulton, Cobb, Clayton and the City of Atlanta charge a flat fee in addition to requiring the retail liquor package stores to pay an annual general business occupation tax. Gwinnett is considered a dry county; therefore, retail package stores are not permitted. DeKalb does not require them to pay a general business occupation tax. The Law Department informed us that the current code would have to be amended if we wanted to begin charging retail liquor package stores a general business occupation tax like the other counties.

The anticipated revenue shown above is a conservative estimate that would vary depending on the gross receipts, number of employees and the fee rate.

Comments

A charge for vehicle extrication was added to the list of proposed fees. Fire Rescue provides approximately 300 extrications per year.

The rate increases will minimally affect Medicare or Medicaid, which represent more that 60% of patients. Those reimbursements rates are established by contract. In addition, a Strategic Plan focus of improved documentation will make an additional impact of approximately \$750,000 in annual revenue, once the rates are in effect.

Fire Rescue recommended developing a Level#4 Collection Notice; this will result in an approximately \$300,000 annual impact on the open collection accounts.
