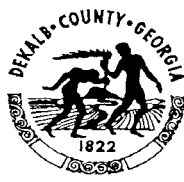

General Information

The American Recovery and Reinvestment Act of 2009 (ARRA) was enacted in February, 2009. Goals of ARRA were to create new jobs, save existing jobs, spur economic activity, and invest in long-term growth. ARRA's methods of achieving these goals included increasing federal funds for education, healthcare, and entitlement programs by \$224 billion and providing \$275 billion for federal contracts, grants, and loans.

The U.S Department of Health and Human Services Administration for Children and Families: Strengthening Communities Grant Program awarded Human Development \$250,000 (Award# 601086). "This collaborative grant award is for providing capacity building services to DeKalb County-based non-profit organizations that are involved in economic recovery efforts. Specific project activities will include free capacity training workshops for at least 50 local faith- and community-based organizations (FCBOs) and one-on-one capacity building technical assistance for at least 20 of the local faith-and community-based organizations."

The grant period is for two years beginning September 2009 through September 2011. Matching funds of \$10,000 are required by the County for each year of the award. The \$20,000 will be used for consulting services.

Scope

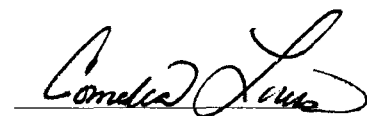
