DeKalb County's "Lights Out/ Power Down" Policy

As DeKalb County Government strives to reach higher environmental goals for both its employees and the public, employees are reminded that unnecessary use of energy costs the County big money. Let's save energy and take a closer look at the County's Executive Order on the "Lights Out/ Power Down" Policy.

- Employees are encouraged to turn lights off in all office and work areas when not in use and at the end of the work day, including nights, weekends and holidays.
- Employees are encouraged to set computers to enter system standby or hibernate after 30 to 60 minutes of inactivity and set monitors to enter sleep mode after 5 to 20 minutes of inactivity.
- 3. Employees are encouraged to utilize natural light from windows for work areas located on perimeters of buildings with windows.
- 4. Employees are encouraged to power down electronic equipment at the end of the work day, including nights, weekends and holidays.
- 5. Employees are encouraged to unplug seldom-used equipment.
- 6. Employees are encouraged to use switch-controlled power strips for seldom-used electronic equipment.
- 7. Facilities Management will discontinue operation of all interior, decorative lighting and exterior lighting of buildings that is not needed for safety or security purposes.

Energy Saving Tips for the Home and Office

- Unplug chargers and small appliances when not in use.
- Power down, shut down vs. logging off your computer after use.
- Set thermostats at 68 degrees during the winter months and 78 degrees during the summer months.
- Report leaky pipes; it also saves water.
- Look for Energy Star office equipment, such as computers, printers and fax machines.
- Run the dishwasher or washing machine only when full.
- Air dry large bulky clothing items/ large pots and pans.

Did you know that DeKalb County Government has an Environmental Preferable Purchasing Policy? "Environmentally preferable" means products and services that have a reduced effect on human health and the environment when compared with competing products and services that provide the same purpose. These products and services have a reduced environmental impact because of the way they are manufactured, used, transported, stored, packaged, and ultimately disposed of and will not harm human health, are less polluting, and/ or minimize waste, maximize the use of bio-based or recycled materials, conserve energy and/ or water and reduce the consumption or disposal of hazardous materials.



Here is a list of Green Supplies that Departments can purchase.

- 1. Printer paper with post-consumer recycled paper. Don't forget to recycle paper in the blue bin.
- Ink and laser print cartridges, can be purchased used from Cartridge World and recycled when empty. Additional saving for refilling an order.
- 3. Green cleaning products, recycling the container at the end of use.
- 4. ENERGY STAR appliances, computers, printers and faxes.
