As has been previously communicated, the County has revised the service request forms and has retrained response crews on the level of detail required to accurately determine if an event is to be properly classified as a building back-up. As these changes were implemented during the 2nd Quarter of 2016, the County anticipated a drop in the number of building back-ups to be reported in this 2016 3rd Quarterly Report when compared with previous quarters. However, an increased concentration on cleaning existing lines during the 3rd Quarter led to an increase in the number of back-ups caused by County contractors. As the details of the building back-ups reflected in this reports indicate, all but three of the building back-ups reported herein are the result of the increased cleaning efforts undertaken by County contractors during the 3rd quarter reporting period. The County has enhanced contractor training in an effort to minimize future building back-ups of this nature.
