The DeKalb County Community Development Department is in the process of completing the 2024-2029 Consolidated Plan for HUD Programs and the Analysis of Impediments to Fair Housing for DeKalb County.

The Consolidated Plan is a planning document that consolidates three different United States Department of Housing and Urban Development (HUD) grant programs into one planning document. In DeKalb County, these programs are the Community Development Block Grant Program (CDBG), Emergency Solutions Grants Program (ESG), and the HOME Investment Partnership Program. The plan will primarily identify the needs of low-to-moderate income neighborhoods and persons and show how the County will meet those needs.

The document will provide guidance and identify priorities for the next five years. Ultimately, the purpose of the Consolidated Plan is to develop viable urban communities by providing resources that will:

- Provide decent and affordable housing,
- improve suitable living environments and,
- expand economic opportunities; principally benefiting low to moderate income persons
