What is CV360?

CloudVergent360, or CV360 for short, is DeKalb County's Oracle Cloud-run, expansive back-office system. Phase 1 of CV360 was focused on HR and Payroll functions, and this current phase will focus on Financial and Procurement Systems and Processes.



Why Move from FMIS to CV360?

CV360's guiding principle is to minimize low/no-value-add work and enhance information guality through the utilization of automation, workflow, reporting, and standardization.

What is FMIS?
FMIS is Financial Management Information System. This is the employee-facing technology used to execute and process day-to-day financial and procurement activities within DeKalb County. It is currently run on Oracle E-Business Suite (EBS).
What technologies will be implemented to replace the current FMIS System?
The existing system is moving from Oracle on-premise to Oracle Cloud. Oracle modules that will be implemented are Oracle Financials, Oracle Project Management, Oracle Procurement, Oracle Supplier Management, and Oracle Inventory.
