

#### What's New with CV360-Phase II?

In December, the project closed out the initial development process. While system development is still underway to continue refining CV360, the first iteration of CV360-Phase II testing, System Integration Testing (SIT1), starts later this month. Additional testing iterations will follow, including another round of SIT and User Acceptance Testing (UAT).

The project team is undergoing Conversions, which is the process for confirming how all the relevant data from the current FMIS will be transferred to the new FMIS. This project's Conversion process is a multi-step approach that takes DeKalb County's specific business needs into account for a smooth transition between systems. Over the next few months, we'll begin to share helpful Conversion-related information within this newsletter.
