

What's New with CV360-Phase II?

CV360-Phase II kicked off in April 2023. Since early May, the project has been in the "Technical & Functional Development Phase." We are currently hosting project demo sessions that combine the Financial and Procurement workflows and upcoming changes. The CV360-Phase II Project team is working hard towards designing and building the new FMIS, and we are looking forward to testing in January!

We are currently in Sprint 5. The CV360-Phase II project team has been keeping up the momentum, and we are not stopping any time soon! During the previous Sprint 4 design cycle, the team completed over 80 User Stories and held over 15 live demonstrations, and the Precipitator Program is about to launch!

System Integrated Testing (SIT 1) Overview & Countdown


The countdown has officially begun for the first System Integration Testing (SIT), which will begin in early January. SIT 1 will focus on cohesively validating the FMIS system with new business process flows. SIT is valuable because it allows DeKalb employees to use personas to execute mock tasks in the system and confirm if CV360-Phase II meets day-to-day business needs.

SIT includes end-to-end scenarios in the following areas:

- Transactions
- Approval Workflows
- Reports
- Two-way Integrations between Boundary Applications and 3rd Party Vendors
- Application Security Roles
- Personalization/Extensions
- Oracle Mobile Application
