Experience Requirements

A. Company Experience (Similar Projects):

1. The Bidder shall provide evidence of having at least five (5) years' operating as the same company (Submit qualifications with Bid Documents);
2. Within the last five (5) years, the Bidder has successfully managed and completed* at least one sanitary sewer line assessment project (PACP/MACP assessments with Cleaning) with a Contract value of \$2.5 million;
3. Within the last five (5) years, the Bidder has successfully managed and completed* at least one PACP scored TISCIT assessment project with a contract value of \$1.4 million or projects totaling 250,000 linear feet of PACP assessment, (Submit qualifications with Bid Documents) and
4. Within the last five (5) years the Bidder has successfully managed and completed* at least 185,000 linear feet of cleaning for sanitary sewer lines greater than 15" diameter, and
5. Within the last five (5) years the Bidder has successfully managed and completed* at least one MACP scored manhole condition assessment (MCA) project with a contract value of \$500,000 or projects totaling 4,500 MACP assessments (Submit qualifications with Bid Documents); and,
6. The Bidder must possess and have experience in the operation of off-road equipment capable of performing TISCIT and Cleaning work located off of the right-of-way (easement machine, TISCIT adapted bobcat, etc.).
7. Additional qualifications must be submitted as required of Sections 01510 and 01530 of the Technical Specifications (Submit valid certification to Project Manager after Notice to Proceed).

B. Key Personnel Experience:

1. The Project Manager and/or Supervisor of field crews shall be qualified to lead this project and must have a minimum of five (5) years of experience as a project manager on similar projects. The project manager shall have been in leadership roles on condition assessment projects of similar scale. (Submit qualifications with Bid Documents)
2. The Data Manager shall have been in a leadership role on inventory and condition assessment projects of similar scale including three (3) years of experience in preparation of reports, management of field data collection, data analysis, data management and quality assurance. (Submit qualifications with Bid Documents)

C. Field Crew & Technician Experience:

1. All field crew leaders conducting and/or evaluating inspections shall have two (2) years' experience in performing PACP/MACP assessment functions and hold a current NASSCO PACP/MACP certification. (Submit valid certification to Project Manager after Notice to Proceed).

2. A PACP certified technician or supervisor shall control operation of television equipment and encoding of inspection data. Should the Contractor utilize any personnel to actually document the inspection results that is not PACP/MACP certified, those inspections shall be refused, and resurvey shall be completely at the Contractor's sole expense.
3. The Bidder's attention is called to the Specifications for additional certifications to be submitted to the Project Manager (Section 01510 CCTV, Section 01530 MCA, Section 01540 Safety, Confined Space, etc.).

* Should the Bidder not have a single project meeting the dollar value, PACP assessment, MACP assessment, and/or large diameter Cleaning criteria of Section A, the County is agreeable to consideration of other accumulated contracts, PACP, MACP and Cleaning work performed under more than one contract with value and quantities completed and accepted within the past five (5) years to meet the requirements. These accumulated projects must sum to or exceed the requirements of Section A, parts 1, 2, 3, and 4.

1. Contract value of \$2.5 million: Submit additional experience for a PACP and/or Large Diameter sanitary sewer cleaning contract with work completed and accepted and with minimum value of \$1 million;
2. PACP Experience: Submit additional experience for PACP (TISCIT) assessments for contract(s) with no less than 100,000 linear feet of inspections completed and accepted each;
3. MACP Experience: Submit additional experience for MACP assessments for contract(s) with no less than 1,000 inspections each completed and accepted;
4. Cleaning Experience: Submit additional experience for PACP (TISCIT) assessments for contract(s) with no less than 50,000 linear feet of inspections completed and accepted each.
