Removal of rotted fluted pilasters




The wood fluted pilasters have extensive termite damage on the 2 corners of the front of the home. One has rotted and broken off and both are beyond repair. No other home in the neighborhood has this faux front. We propose removing the 4 pilasters and placing corner boards. The home would continue to have full length shutters along the front windows.



Replacement of front door



The current front door has been damaged, especially on the bottom. If refinished, the door would be leaky without a seal and inefficient.





Current 4 panel door with 2 windows can be replaced with similar 4 panel door with 2 windows to simulate the original door.
