The amendment to Sections 13.5-2 and 13.5-8 of the Historic Preservation Ordinance requires a certificate of appropriateness be approved prior to the subdivision, aggregation, or alteration of the boundaries of existing lot(s) of historic properties and in historic districts designated by the Board of Commissioners.

3. Applications for Certificate of Appropriateness

Applicants and others may speak for or against an application for a certificate of appropriateness or an application for comment, and each side will have five minutes to present its case. In reviews of zoning code applications each side will have ten minutes.
