






LIMITED WARRANTY, DISCLAIMER, AND LIMITATION OF LIABILITY AND REMEDIES ("Limited Warranty")

10.10.16

WHAT THIS LIMITED WARRANTY COVERS: This Limited Warranty applies only to new Wood Double Hung Window Units, Wood Stationary Window Units, and/or Wood Transom Units manufactured and sold by BFS East, LLC (individually or collectively depending upon the purchase, the "Product"). Subject to the limitations, exclusions, and disclaimers set forth below, BFS ("BFS") warrants to the original purchaser of the Product and the original owner of the property in which the Product is installed (the original purchaser and original owner of the property in which the Product is installed are referred to collectively as the "Owner") as follows only for the periods described below, and Owner shall be entitled to the following during the periods set forth below:

- I. For 1 year from the date of original Product purchase: the furnishing of a replacement of the Product's frame, or the balance system and hardware in the Product, found to have a significant defect in material or workmanship under normal usage and conditions;
- 2. For 10 years from the date of original Product purchase: the furnishing of replacement insulated glass incorporated in the Product found to have a seal failure resulting in moisture between the glass, visual impairment caused by the deterioration of a glass coating, or residue build-up between the glass impairing vision:
- 3. For 10 years beginning after the expiration of 10 years from the date of original Product purchase: the furnishing of replacement insulated glass incorporated in the Product found to have a seal failure resulting in moisture or film that causes impaired vision at a charge to Owner of fifty (50) percent of the then-current price of the replacement insulated glass as of the date the warranty claim is made.

WHAT THIS LIMITED WARRANTY DOES NOT COVER: The following limitations and exclusions apply to this Limited Warranty:

- This Limited Warranty does not apply to any other products or materials sold by, or services furnished by or on behalf of, BFS and applies only to the Product.
- Broken glass is not covered.
- Wood rot, degradation of wood parts, or insect infestation is notcovered.
- Seal failure that results from water penetration after the deterioration of wood parts in the Product is not covered.
- Insulated glass, impact-resistant glass, or laminated glass covered by a warranty issued by another manufacturer or supplier is not covered.
- Glass or glass seal failure as a result of heat buildup, or pressure from the installation of aftermarket film or other accessories, is not covered.

- Glass or glass seal failure resulting from the installation of the Product in property at altitudes exceeding 3,500 feet elevation is not covered.
- Minor imperfections that do not impair the integrity or performance of the Product or glass or the glass seal
 in the Product as determined in BFS's sole discretion are not covered.
- If a glass seal failure is otherwise covered by the Limited Warranty, the replacement glass that may be furnished may not have been manufactured by the same glass manufacturer or match the original glass part number, and the furnishing of glass that is an exact match to the original is not covered.
- Any Product or component in a Product that is altered or abused as determined in BFS's sole discretion, or that is installed by a party other than BFS, is not covered.
- Any Product that is installed in an Exterior Insulation and Finish System or Direct-Applied Exterior Finish System (both also sometimes commonly known or referred to as synthetic stucco), or in an environment that does not allow for proper drainage of moisture as determined by BFS in its sole discretion, is not covered, and installation of the Product in an Exterior Insulation and Finish System or Direct-Applied Exterior Finish System, or in an environment that does not allow for proper drainage of moisture as determined by BFS in its sole discretion, VOIDS all warranties contained herein.
- Damage to the Product due to improper or incomplete finishing of exterior/interior wood or composite surfaces, failure to provide annual maintenance related to the Product (such as, by way of example only, sealing and caulking), or deficiencies in building design or construction as determined in BFS's sole discretion are not covered.
- Damage to surface areas of the Product or leaks due to power-washing, brick cleaning, sanding, chemicals, salt, airborne pollutants such as salts or acid or any other misuse is not covered.
- Condensation on the Product and resultant water damage as a result of excess humidity is not covered.
- Product hardware finishes are not covered.
- Damage to the Product due to exposure to conditions beyond published performance specifications or use in
 a pool area or other harsh surface environment, or fire, flood, earthquakes or other acts of nature is not
 covered.
- Product not installed in accordance with BFS's installation instructions and damage to the Product resulting therefrom are not covered.
- If PVC parts are used in or are part of the Product, these PVC parts are not covered if the PVC parts are painted without strict adherence to the PVC manufacturer's paint requirements.
- The application of paint of any kind to the Product's balance system or hardware VOIDS all warranties contained herein.
- This Limited Warranty covers material only. BFS is not responsible for, and this Limited Warranty does not cover, labor and/or materials or other costs that may be incurred by Owner for removal, shipping, delivery, installation, painting, refinishing, or any other labor or other costs associated with replacement of a Product or a component in a Product.
