Elector Registration Challenge

Pursuant to 21-2-230

August 22, 2024

TO: DeKalb County Board of Registrations and Elections

FROM: William Henderson, Registration ID 03183834, Resident of DeKalb County

Honorable Board Members:

The purpose of this letter is to challenge, according to O.C.G.A. 21-2-230, the registrations of DeKalb County electors who have filed a permanent address change with the NCOA system, registered to vote in another state at the new address indicated on the NCOA form, and subsequently voted in that foreign state.

If this probable cause hearing is sustained, the registrations shall be processed in the manner set forth in GA Code 21-2-230.

Relevant Georgia Code Citations

OCGA 21-2-216 Qualifications of electors generally . . .

- (a) No person shall vote in any primary or election held in this state unless such person shall be:
- (2) A citizen of this state and of the United States;
- (4) A resident of this state and of the county or municipality in which he or she seeks to vote
- (f) No person shall remain an elector longer than such person shall retain the qualifications which such person registered.

OCGA 21-2-217 Rules for determining residence

(a)(2) A person shall not be considered to have lost such person's residence who leaves such person's home and goes into another state or county or municipality in this state, for temporary purposes only, with the intention of returning, unless such person shall register to vote or perform other acts indicating a desire to change such person's citizenship and residence;

(a)(13) If a person goes into another state and while there exercises the right of a citizen by voting, such person shall be considered to have lost such person's residence in this state;

OCGA 21-2-230 <u>Challenge of persons on list of electors by other electors</u>. . .as found in the newly adopted SB 189

Elector Registration Challenge

Pursuant to 21-2-230

(a) . . . If a challenged elector's name appears on the National Change of Address data base, as maintained by the United States Postal Service, as having changed such elector's residence to a different jurisdiction, the presence of such elector's name on such data base shall be insufficient cause to sustain the challenge against the elector <u>unless</u> additional evidence would indicate that the elector has lost his or her residence as determined pursuant to Code Section 21-2-217

NVRA 1993

Section 8(d) REMOVAL OF NAMES FROM VOTING ROLLS.

- (1) A State shall not remove the name of a registrant from the official list of eligible voters in elections for Federal office on the ground that the registrant has changed residence unless the registrant---
 - (A) Confirms in writing that the registrant has changed residence to a place outside the registrar's jurisdiction in which the registrant is registered;

REASONING: When a registered voter applies to vote in another state, he is asserting in writing that he has changed his address and is a legal resident of the state in which he is applying to vote. (Note, this challenge, under GA Code 21-2-230, does not mandate, request or require the removal of any registrant from the list of eligible voters.)

Confirmation from the foreign Secretary of State's website that the person has registered to vote in its state proves that his/her eligibility to vote is in the new state. If the person also votes in that state, it is double proof that he/she now resides in the new state and is no longer an eligible elector in Georgia.

This hearing is to determine 'probable cause' that the elector is ineligible to vote in the upcoming election(s) because they currently reside, have registered to vote and may have voted in another state, rendering their eligibility to vote in Georgia invalid. If this probable cause hearing is sustained, no further hearing by the board of registrars is required until **after the election**, and the processes defined in GA Code 21-2-230 shall be applied:

GA Code 21-2-230 (f): If the challenged elector does not cast an absentee ballot and does not appear at the polling place to vote and the challenge is based on the grounds that the elector is not qualified to remain on the list of electors, the board of registrars shall proceed to hear the challenge pursuant to Code Section 21-2-229.

This challenge, if sustained, is valid through both the general election and any runoffs:

GA Code 21-2-230 (k) Any challenge of an elector that occurs during a primary or general election shall continue through the run-off primary or run-off election of such primary or general election.

It is to be further noted:

Elector Registration Challenge

Pursuant to 21-2-230

GA Code 21-2-230 (j) Failure to comply with the provisions of this Code section by the board of registrars shall subject such board to sanctions by the State Election Board.

I believe the evidence submitted provides more than sufficient "probable cause" for the challenges to go forward for the general election cycle and will help ensure that only qualified resident citizens of Georgia will vote in the election. As you know, sustaining these challenges does not remove them from the list of voters; it merely requires proof of Georgia residency upon an attempt to vote.

The importance of this process cannot be understated. None of the listed electors in this challenge will be deprived of their Constitutional right to vote. However, if any one of these electors is subsequently found to have voted in Georgia in conflict with established election laws, that will deprive another voter of their Constitutional right to have their vote counted, and will therefore require an additional voter to reinstate the balance of the vote in general. This possible situation therefore, in theory, deprives two valid, legal voters of their Constitutional rights. This challenge helps minimize the chances for that situation to occur.
