
Post Office and UPS Store/ Mail Center addresses used as Residence Addresses. 21-2-230 Challenge

Honorable DeKalb County Election Board:

As a citizen of Georgia and a resident of DeKalb County, I hereby challenge the attached registrations under GA Code 21-2-230 as having probable cause to indicate they are invalid/illegal under GA Code 21-2-561. These registrations, according to the August 13th, 2024 DeKalb County Voter Roll, have RESIDENTIAL ADDRESSES that are the addresses of either U.S. Post Offices, UPS Stores or other Mail Center businesses that are stand-alone structures. These addresses cannot be used as residential addresses.

It can reasonably be assumed that these addresses contain PO Boxes to which mail can be delivered. While these boxes may belong to a valid elector, it is impossible to determine in which Municipal, State Senate, State House, US Congressional districts, or possibly even what State the elector truly should be qualified to cast a vote.



Evidence:

According to the official Georgia State Voter Registration form, shown above, Box 2 is labeled. RESIDENCE ADDRESS. Box 3 is labeled MAILING ADDRESS. The MAILING ADDRESS is accompanied by the instructions "If different from residence address. PO Box or route." This reasonably indicates that if the elector chooses to receive mail at a different address, or a PO box, they should list that address in Box 3, Not Box 2.

In addition, Box 6 requires the elector to swear or affirm that they RESIDE at the address listed above. They cannot reside in a Post Office, UPS Store or standalone Mail Center, much less in a box at that location. The WARNING states that any person who knowingly gives false information when

using this form is guilty of a felony (O.C.G.A 21-2-561). It can only be assumed that these stipulations apply to any method in which the elector is registered to vote.

I, as the challenger, am not accusing anyone of committing a felony. However, these registrations, as they are published in the DeKalb County Voter Roll, are illegal on their face. As such, I am challenging these registrations under GA code 21-2-230. These registrations should be marked as CHALLENGED. If any of these electors attempts to vote in the next election, either in person or by absentee, the elector should be required to show proof of their DeKalb County RESIDENCE ADDRESS and amend the registration in accordance with the procedures set forth in GA Code 21-2-230.

To be clear, GA Code 21-2-230 does NOT entail any registrations or electors to be removed from the voter roll. So, the NVRA 90-day rule does not apply. GA Code 21-2-230 states a 45-day rule for submission of this type of challenge. This challenge is well outside that period. The Elections Board must determine whether probable cause exists to sustain this challenge.

In determining probable cause, GA Code 21-2-230 states: "Probable causes shall include, but not be limited to, an elector who is deceased; an elector voting or registering to vote in a different jurisdiction; an elector obtaining a homestead exemption in a different jurisdiction; or an elector being registered at a nonresidential address as confirmed or listed by or in a government office, data base, website, or publicly available sources derived solely from such governmental sources."

In addition, GA SB189, passed and signed into law states (Section 4 (a) (2) (C)): "Prooftoftownership or rental ofta post office box or private mailbox service address within a particular jurisdiction shall not constitute sufficient grounds to establish a person's residency within that particular jurisdiction;"

I have verified those addresses by searching Google Maps to show the structures that exist at those addresses. I would be glad to furnish my complete lists upon request.

All of the registrations I have listed in this challenge have an EXACT MATCH to the addresses of either a USPS address or a UPS Store or Mailing Center. This is NOT a 'systematic search'.

I further testify that I do not personally know any of these electors, nor have I tried to contact any of them. All of the research done for this challenge was carried out by me alone.

So, in conclusion, there exists substantial 'probable cause' for each one of these registrations to be verified and corrected via a 21-2-230 challenge. Each one lists an invalid and potentially illegal address. It is verified by a list of addresses from valid public websites that have no reason to misinform their customers, and by locating and showing photographs of the structures that exist at these addresses from the Google Map website, which millions of people rely on for accurate information. These structures are either free standing buildings or part of a commercial property

with no apparent residential units. Since these structures are not residential buildings, it is impossible to determine where and in what precinct, district, jurisdiction or even state the elector actually resides. These registrations must be corrected before a vote can be cast by them.
