Enables citizens to be an integral part of the decision-making process.


A formalized means for individual citizens to have a voice in the public review process.

The County recognizes that residents have a unique relationship with a place that Staff and decision makers may not have.


Residents can provide new information and a diverse perspective on a project, resulting in a better outcome.

# RESPONSIBILITIES OF THE CHAIR AND VICE-CHAIR

- Promote an atmosphere of courtesy and respect at meetings.
- Applications are discussed in the time allotted by running an efficient meeting (Robert Rules of Order).
- Basically, treat applicants as you would like to be treated.



## RESPONSIBILITIES OF MEMBERS



- Prepare in advance for the meeting! Staff
  posts applications and agendas on our
  website (see resource slide) prior to every
  meeting.
- Visit project sites safely.
- Base your comments on merits of the application.
- Avoid personal attacks or pre-conceived notions about applicants.
- Avoid long passionate, personal speeches.
- Make motions, second or amend motions, vote.


