Application request by W. Barry Dunlop for a subdivision of approximately 1.05 acres to construct three (3) single-family detached dwellings. The subject property is located in the R-75 (Residential Medium Lot-75) Zoning District and Tier 2 of the Scottdale Overlay District and is nearest to the intersection of Booker Avenue and Robinson Avenue.
