Bidders or its authorized representative shall sign in with a representative of DeKalb County’s Purchasing and Contracting department at the site visit as proof of attendance. An additional Site Visit of the water storage tanks listed 7 thru 12 on Attachment N-Tank Locations Day 2 will be held on the 20th day of October, 2021 starting at 9:00 A.M. at the Redan #1 and #2 - Ground Storage Tanks, 1300 Panola Road, Stone Mountain, GA 30088. Bidders or its authorized representative shall sign in with a representative of DeKalb County’s Purchasing and Contracting department at the site visit as proof of attendance. - C. We have received additional questions pertaining to this Invitation. The questions and their resulting answers appear below:

1. Question: What HMI software are the two Siemens PLC using? If it is compatible with Allen Bradley, do you have engineering license for your specific HMI software.

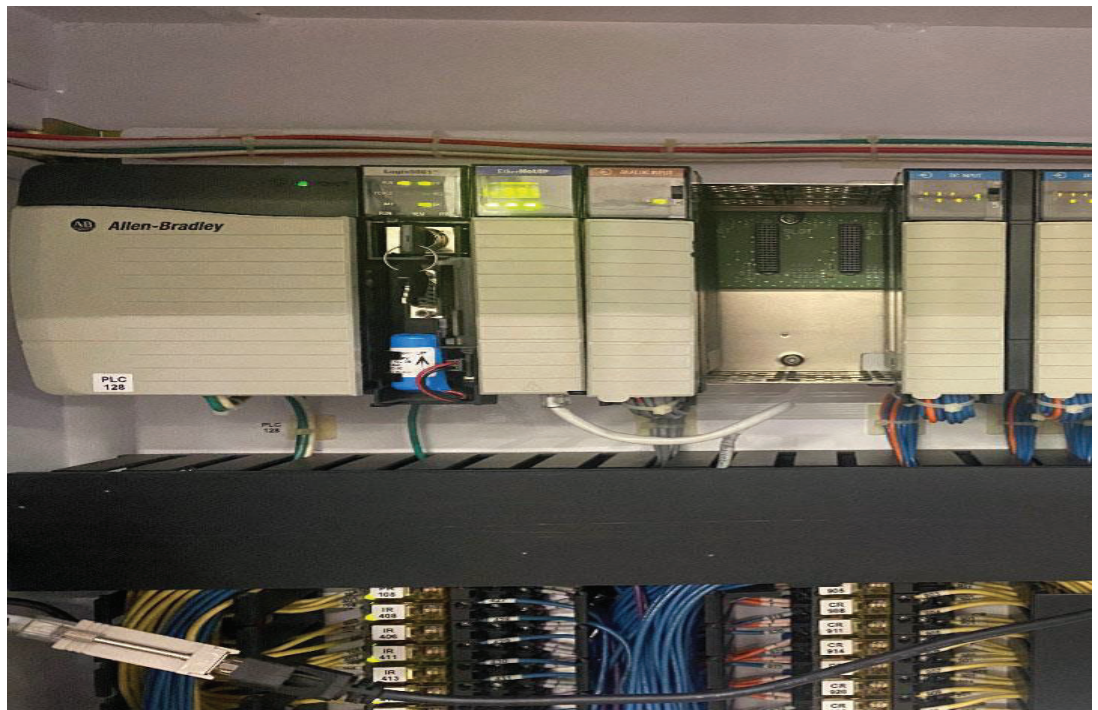
Answer: The Siemens PLCs do not have HMI panels at the tank itself but are using FactoryTalk to communicate back to the filter plant. Yes, engineering licenses are in place for the HMI software being utilized.

2. Question: Good afternoon to you and based on the Extended Bid Date; the contractors for the Instrumentation portion of the project would like to view each water tank; please and thank you. We feel this will help with providing a competitive cost proposal.

Answer: An additional site visit for the elevated and ground tanks has been scheduled for October 19, 2021 and October 20, 2021. The site visits are optional. See Modification to the Bid Nos.: 2 - 4.

3. Question: For the Controllogix system at Lithonia - Ground Storage Tank, Does it have enough spare slot in the Chassis for the additional AI card? If not, how many existing card in the system?

Answer: Yes. The Controllogix at Lithonia has additional slots for an AI card. Below is a picture of the PLC and Rack.
