Invitation to Bid (ITB) 22-101488 Consent Decree: Find and Fix Assessment and Rehabilitation (CD: FFAR) [Multiyear Contract] is hereby amended as follows:

No requests for interpretation, answers to scope or specification questions, contract exceptions, or additional information shall be accepted after Monday, August 22, 2022, at 5:00 P.M. EST.

All qualifying Contractors and Subcontractors performing work with DeKalb County, Georgia must register and participate in the federal work authorization program to verify the work eligibility information of new employees. Bidders will submit the Affidavit of Compliance with O.C.G.A. §13-10-91.
