Should this statement reference MSRB Series 50 & 54 Certifications? Rules G-37 and G-38 apply solely to broker-dealers, rather than Municipal Advisors.		
	Answer:	Yes		
O.	Question:	I missed the call on the LSBE. Does that mean I am out?		
	Answer:	The County will accept all proposals, but in order for a proposal to be considered responsive and considered for award, the proposer must have attended at least one of the mandatory LSBE meetings.
