ADDENDUM NO. 2

Invitation To Bid (ITB) No. 19-101152, Fire Rescue Emergency Medical Supplies is hereby amended as follows:

1. We have received questions pertaining to this Invitation To Bid. The questions and their resulting answers appear below:

A. **Question:** Is this set to be an All or None bid or a Line Item bid? Must we bid on every item to be considered?

Answer: No, it is preferable that all items are bid. Refer to section C(2) Contract Award on Page 8 of the solicitation.

B. **Question:** Please provide current part numbers and ndcs.

Answer: See Revised Price Schedule attached hereto.

C. **Question:** Who is the incumbent for this contract?

Answer: We do not currently have a contract in place.

D. **Question:** Are you required to quote all items?

Answer: You are not required to bid all items. If you do not have access to an item, please submit a comparable single sample of your bid item for evaluation.

E. **Question:** Will there be multiple awards?

Answer: This is possible as there are many items listed. Refer to section C(2) Contract Award on Page 8 of the solicitation.

F. **Question:** Line 30. Curaplex Neb Kit, need to know the contents?

Answer: Nebulizer contents include One (1) multi-adapter 15mm connection, one (1) small volume nebulizer with T-piece, mouth piece, flex tube 7 feet, and one (1) elbow adapter connection.

- G. **Question:** Line #42 and #43 - Curaplex Miller and Mac Blades: Are these Conventional, LED or Fiber Optic? Reusable or Disposable? Metal or Plastic?

Answer: The Curaplex Miller and Mac Blades are disposable, fiber optic and stainless steel.

- H. **Question:** #54-58 Microflex gloves- which kind? There are many to choose from? Supreno? FreeFpr, Ultra One? Latex or Nitrile?

Answer: Nitrile Supreno Gloves or equal (Provide Sample)

- I. **Question:** Line #63 BioHazard Bags red - What size?

Answer: Sizes 7 to 10 gallon capacity

- J. **Question:** Line #64-65 C-Collar - Are these adjustable collars or one piece?

Answer: The C-Collars are adjustable collars for both adult and pediatric.

- K. **Question:** Line #67 DMS Back Board Straps- do you have a DMS product code, or the makeup of the strap? Length? Material? Buckle? Ends?

Answer: DMS backboard strap model # 11162BK, nylon webbing, 6 feet length, 2.5 inch width, medal buckle.

- L. **Question:** Line #69 4x4 Non-Sterile - How many per pack or box and ply?

Answer: Non-sterile 200 per pack 4 ply.

- M. **Question:** Line #70 4x4 sterile – How many per pack or box and ply?

Answer: Sterile 100 per box 12 ply.

- N. **Question:** Line #92 Graham Medical Disposable Blankets - What kind of size of blanket?

Answer: Graham Medical Blanket made of polyester and size 50 inch x 84 inch.

- O. **Question:** Line #93 Sterile Water - What size?

Answer: Sterile Water 500 ml

- P. **Question:** Line #94 Electrode Blue Sensor - Need a product code for accurate bidding and size of package.

Answer: Electrode Blue Sensor Ambu Blue Sensor ECG Electrodes Ref SP-00-S/10

- Q. **Question:** Line #99 Laryngoscope Handle will depend on answer to #42/43

Answer: Laryngoscope Handle, Stainless Steel Non-Disposable

- R. **Question:** Line #101 & 102 these are exclusive to the manufacturer Teleflex, there is not a distributor that can sell them, can these be removed from the bid since this is an all or none bid?

Answer: No, Line Item Nos. 101 and 102 will remain on the bid schedule. If you do not have access to an item, please submit a comparable single sample of your bid item for evaluation.

- S. **Question:** Line #122-124 Arrow IO Needles go with #101/102 exclusive to Manufacturer

Answer: No, Line Item Nos. 122 and 124 will remain on the bid schedule. If you do not have access to an item, please submit a comparable single sample of your bid item for evaluation.

- T. **Question:** Line #127 Pelian 1550 case, is this empty? With foam and dividers, or the EMS case with the lid insert?

Answer: Line Item No.127 is with foam, dividers, and lid insert.

- U. **Question:** Line #132 ResqPods are exclusive to Zoll only there are no distributors that can sell this product, will this be removed?

Answer: No, Line Item No. 132 will remain on the bid schedule. If you do not have access to an item, please submit a comparable single sample of your bid item for evaluation.

- V. **Question:** Line #134-136 Conforming Stretch Gauze is this sterile or non-sterile?

Answer: Conforming Stretch Gauze, we carry both sterile and non-sterile gauze, specify on bid.

- W. **Question:** Line #137 Telefle MAD Device which one, with syringe or none?

Answer: Line Item No. 137 Telefle MAD Device, 3cc syringe

X. **Question:** Line #140-174 please include how you want the product, syringe, vial, etc.

Answer: See attached Revised Price Schedule attached hereto.

Y. **Question:** Line #179-180 Exclusive to Teleflex will these be removed?

Answer: No, see response to question R. If you do not have access to an item, please submit a comparable single sample of your bid item for evaluation.

Z. **Question:** Line #199 Atomization Device need more information.

Answer: Line Item No. 199, Atomization Device, Intranasal atomization delivery.

AA. **Question:** How do you intend to award this bid? Will you be awarded the entire opportunity to one vendor or will it be awarded by line item?

Answer: Refer to section C(2) Contract Award on Page 8 of the solicitation.

BB. **Question:** Some of the products on this bid are exclusive to one vendor and we do not have the ability to bid. If we cannot provide the product being specified, will we be removed from consideration for award if awarded as an all-or-none?

Answer: No, submit one alternate sample of what you intend to bid for evaluation.

CC. **Question:** Examples are lines 101, 179 & 180. We do not have the access to sell EZ-IO.

Answer: Submit alternates for comparison, however note we do currently utilize EZ-IO devices.

DD. **Question:** Some of the pharmaceuticals being requested we do not have access to or the dosages do not exist. Would you consider removing the “no sub” restriction and allow for alternatives to be bid for every line?

Answer: Pharmaceuticals are listed by dosages and manufacture currently used. These items as listed are “familiar” to the crews operating in the field by dosage, color, and packaging. If there is an alternate with the same dosage (mg/ml), color, and packaging then submit a single sample for evaluation.

EE. **Question:** Example line #140 for Morphine. There is no 6mg vial that exists.

Answer: This should be 5mg vial. See Revised Price Schedule attached hereto.

FF. **Question:** Given the volatile nature of the pharmaceutical industry and not always being able to acquire manufacturer documentation of increases, if proposed increases are not accepted by the County at time of renewal, will the County allow for those products to be removed from the contract with no prejudice against the awarded vendor?

Answer: It is the desire of the County to keep all listed items under contract. Refer to section C(2) Contract Award on Page 8 of the solicitation.

GG. **Question:** Given the complexity of this opportunity with the LSBE requirement, would an extension be granted so that we have adequate time to respond to the answers that will be addressed after the question deadline?

Answer: The solicitation per Addendum No. 1 was extended to January 13, 2020.

HH. **Question:** FOREIGN PRODUCTS, we are a distributor, are you expecting us to find out where all the 200+ items we are bidding are made if not made in the US and list all of this?

Answer: This requirement is being relaxed/amended to provide the percentage of items bid that are not made in the US

II. **Question: PAYMENT Invoices should be signed by the Bidder, are we required to sign every invoice?**

Answer: Invoices must be submitted on vendor's letterhead and in compliance with section N(1) Payment page 13 of the solicitation

JJ. **Question:** – On the glove portion of the bid it states Microflex with no substitutes, what Microflex glove are you using now? Who was the previous vendor to supply these gloves to you?

Answer: See Question H response. The previous vendors to supply the Microflex Safe-Flex gloves are Grainger and Uline.

2. Page 21, Minimum Specifications – **DELETE** the following: THIS IS TO BE AN ALL OR NONE BID***ONLY ONE (1) SUPPLIER.

3. **DELETE**: Price Schedule, Pages 22-27 of the solicitation
INSERT: Revised Price Schedule, Pages 22-27 attached hereto.

(Failure to utilize the Revised Price Schedule attached hereto will cause your bid to be deemed non-responsive. The Price Schedule must be submitted in a separate, sealed envelope.)

4. It is the responsibility of each bidder to ensure that he/she is aware of all addenda issued under this ITB. Please sign and return this addendum with your response. 5. All other conditions remain in full force and effect.
