2. We have received questions pertaining to this Invitation. The questions and their resulting answers appear below:

A. Question: Please clarify on Page 21, Section I.A. Framework, number 2., it states: “Shall have 12 inch x 26 lb/ft channel main frame SM of 34 and YS of 50,000 PSI ”. This does not match any standard C Channel. The C 12x30 lb/ft only has a SM of 27. Is this a typo?

Answer: The specification should state: “Shall have 12 inch x 26 lb/ft wide flange beam main frame and YS of 50,000 PSI”.

B. Question: We would like to propose a more standard W14 x 90 I-beam on the main frame, which is heavier than their specified C-channel. The 90 lb/ft is necessary if you want to maintain a 34 SM or higher.

Answer: Just as long as the size of the main frame strength is at least 12 inch x 26 lb/ft wide flange beam main frame and with a YS of 50,000 PSI. Anything more would be fine.
