- 2. We have received questions pertaining to this Invitation. The questions and their resulting answers appear below:
  - A. <u>Question</u>: Point 16: We can have the ground control activation of the Light with FX504.

<u>Answer</u>: Not sure what a FX504 light is but Fleet is asking for the outer boom to be equipped with a factory installed LED work light with a switch at the main control and on the remote control.

B. <u>Question</u>: Point 17: There is a parking control switch as special option.

<u>Answer</u>: Not sure what the question is but as stated in the bid, "Boom out of stow alarm and light in dash <u>shall</u> be installed to ensure boom is stowed for transport".

C. Question: Part D: Comply with double motoreducer option.

<u>Answer</u>: Fleet is requesting the crane to have 2 rotate motors for the rotation system.

D. <u>Question</u>: Part E., Point 9: We have bubble on each level without mirror.

Answer: Needs to have a mirror.

E. <u>Question</u>: Part F., 1,2.: The crane is with radio so no sense for the LED on the control station. Do they want a top seat?

Answer: Fleet does need LED lighting at the control station. No top seat is needed.

F. <u>Question</u>: Our standard for fitting is JIC.

Answer: That is fine.

G. <u>Question</u>: Point 9: what do they mean?

<u>Answer:</u> Needs to have the hydraulic hoses that are routed on the crane to be covered with flexible covering, such as a hose protector sleeve or spring guard.

H. <u>Question</u>: Point G. 11: Offer with ADC (automatic dynamic control).

<u>Answer:</u> Item No. 11 is asking for the crane to have a hydraulic oil tank that does not interfere with the crane operation.

- I. <u>Question:</u> Part 1:
  - 1. Possible only 8 fixing bolts.
  - 2. Compensator not possible.
  - 3. We can offer inorganic zinc primer for extra corrosion resistance.
  - 4. Extra transparent layer for pain option 95. R1.

Answer: These seem to be statements and not questions but the answer to number 3 is fine.

J. <u>Question</u>: Has the funding been approved for this piece of equipment?

Answer: Yes

K. <u>Question</u>: Is this replacing an in service unit and do you have the previous manufacturer and or pictures?

<u>Answer</u>: Yes, it is replacing the 2009 IHC 7600 Truck with IMT 52/38 Knuckleboom Crane, 20' flat bed, 67" max reach with 22.570 lb. max capacity at 15' radius and boom mounted winch with 2500# pull capacity. Rush was the awarded vendor. No pictures available.

L. <u>Question</u>: Any indication on the quantity of units on this bid?

Answer: Yes, we are seeking to purchase only 1.

M. <u>Question</u>: How many of these vehicles are currently in the DeKalb Fleet?

Answer: 8

N. <u>Question</u>: Is there a preferred chassis make for this build?

<u>Answer</u>: Yes, Freightliner since they are the only manufacturer that will put a 12 liter Cummins engine in the truck.
