- 1. **Modification to the Bid:**
 - A. Please replace the previous bid package with the revised bid dated 5/12/21.
- 2. The following changes have been made in the revised bid package:

- Page 21, Item D. #1
 1.GVWR 35,000 lbs.
- Page 21, Item F. #1
 - 1. Weight Rating 23,000 lbs.
- Page 25, Item H. #3
 - 3. 3-point "D" handle compression locks.
- Page 26, Item P. #3-5
 - 3. Floor Width 54"
 - 4. Side Compartment Height 58"
 - 5. Side Compartment Height 20"
- Page 26, Item Q. #1-4
 - 1. First Vertical = 32" length x 78" height through compartment
 - 2. Second Vertical = 22" length x 58" height
 - 3. Horizontal = 54" length x 24" height
 - 4. Third Vertical = 24" length x 58" height

- Page 26, Item R. #1-4
 - 1. First Vertical = 32" length x 51" high through compartment
 - 2. Second Vertical = 22" length x 51" high x 20" deep
 - a. 54" x 27" x 24" deep open compartment for hose reels below the 1st and 2nd vertical compartments.
 - b. 1st and 2nd vertical compartments to have (1) aluminum shutter type door.
 - 3. Horizontal = 54" length x 24" high
 - 4. Third Vertical = 24" length x 58" high
- Page 26, Item S. #1
 - 1. No standard shelving provided all vertical compartments have shelf clips for use with eight (8) shelves. Shelf locations to be determined by Dekalb County.
- ADDED ON PAGE 28, Item AA. #1-2
 - 1. Two (2) Chock block holders, approximately 12" x 12" x 15" triangular shaped, behind rear wheels in fender skirt on both sides of the body. Provide one pair of chain connected in each holder.
 - 2. Rhino liner or comparable spray in bedliner to cover floor up to the top of the toolbox, front of bulkhead, and top and face of bumper.
