1. Is there a document that list the total number of acres to be maintained for this project and will there be scheduled site visits?

Response: No, there is no document available that lists the total number of acres to be maintained. Please see our Price Schedule with breakdown of proximity service area in mileage for each location.

No, there will NOT be a scheduled site visit. All locations publicly accessible, bidder shall be responsible for conducting a site visit of the service locations on his/her own time, and to familiarize himself/herself with the conditions of the locations prior to submitting a bid.

2. Is there a bid range for this project?

Response: The County does not have a bid range for the project, but expect that the bid prices would be comparable to or within the current market prices.

3. What is the county currently paying for the services?

Response: The total cost in 2021 is approximately \$1.1M

4. Will the county permit access to landfills to dispose of debris from the right of ways at a reduced or no cost?

Response: Yes, the contractor(s) for this project is allowed to utilize our Seminole Landfill to dispose debris collected from the ROW at the following rates:

\$16.50 minimum charge (under one ton)

\$33.00/ton

5. Is weekend work permitted?

6. Is there a need for Special clean ups after major events in certain areas?

Response: No

7. What is the expect date to begin this project?

Response: The estimated begin time for this project is April 1, 2022.
