**ADDENDUM NO. 1**

Invitation to Bid (ITB) No. 22-101528, *Exercise Equipment*, is hereby amended as follows:

1. We have received questions pertaining to this Invitation. The questions and their resulting answers appear below:
  - A. **Question:** Delivery to be made to the Fire and Rescue Supply and Equipment Shop, can the bid items be drop-shipped directly there? In other words, the items don't have to be delivered all at one time, they can be received by DeKalb personnel.  
**Answer:** Yes
  - B. **Question:** Is there a loading/unloading dock there, does it have double doors?  
**Answer:** There is no loading dock, however there are double doors, and we have a Forklift.
  - C. **Question:** There is no assembly that the selling dealer need be concerned with to be included on the equipment bid, correct? DeKalb staff will assemble any products that need assembly, correct?  
**Answer:** Correct
  - D. **Question:** Regarding the Red Barn 4'x6'x3/4 Horse Stall Mat: is there a specific brand that is being requested? Or can we quote any brand that meets the specifications?  
**Answer:** Red Barn is the brand name.
  - E. **Question:** What is your delivery timeline and expectation?  
**Answer:** We understand lead times are extensive, however we do have to consider Grant requirements. Delivery should be no later than March 1, 2023
