<u>Answer:</u> Yes, DeKalb County is in need of durable compactors specifically designed to compress and contain Municipal Solid Waste (MSW). Compactors shall have continuous feed capability while operating. The contractor will be responsible for delivering compactors to and unloading the compactors at DeKalb County's Seminole Road Landfill.

**Question**: Will there be any consideration made regarding the Steel Index as it has been very volatile since the beginning of the year?

<u>Answer:</u> Yes, as pre the price escalation clause which states: During the life of the contract, the awarded bidder shall furnish price lists to the County for increases, and those of the bidder's supplier (e.g. factory) increases, as prices change. The bidder must also provide a list of the supplier's (e.g. Page 1

factory's) previous price(s) to the County for purposes of Page 12 of 44 Revised 02/19/2021 P&C comparison. Price changes will be in effect only after receipt and approval by the Director of the Department of Purchasing and Contracting. Price lists and changes thereto are to be furnished under the contract and without charge to the County.
