ADDENDUM NO. # 1

ITB No.: 19-101168, FRAZIER ROWE PARK – SITE PREPARATION, PAVILION ASSEMBLY AND INSTALLATION, is hereby amended as follows:

1. We have received questions pertaining to this Request for Quote. The questions and their resulting answers appear below:

A. **Question:** Will the park remain open to the public during the renovations?

Answer: This will be up to the contractor. If certain areas of the park need to be closed for safety, we will communicate to the community.

B. **Question:** Confirm tree removal scope would be performed by Dekalb County?

Answer: DeKalb County will remove any trees.

C. **Question:** Is weekend work allowed? If so, what are the weekend working hours?

Answer: Yes, weekend work is allowed from 9am to 7pm.

D. **Question:** What are the lane closure hours?

Answer: This would need to be discussed with the Department of Transportation. Once the contract is executed, a request can be made for the day and time, for approval.

E. **Question:** Will the Permit Fee be waived for this project?

Answer: There are no permit fees associated with this project.

- F. **Question:** Could you provide detailed drawings on: (a) the sidewalk and (b) the amenities concrete pads.?

Answer: All details are available on P&C’s website. It is the responsibility of the bidder to download this information.

- G. **Question:** Where is the desired location of the construction exit?

Answer: There is no desired location of the construction exit. After the execution of the project, the location will be discussed at the kick-off meeting.

- H. **Question:** What is the expected start date for this project and what is the duration of this project?

Answer: As soon as possible.

- I. **Question:** Is there a construction schedule?

Answer: This will be determined at the kick-off meeting.

- J. **Question:** From Attachment A/Scope of Work, Section I, No. 1: “Perform initial audit at each playground”. Shall this audit include accessibility issues or safety only?

Answer: No, this is a full audit of any safety issues present.

- K. **Question:** From Attachment A/Scope of Work, Section I, No. 4: “Apply the knowledge to remove hazards and establish a system of inspections.” Does that include scheduling/coordinating high frequency inspections by Parks staff?

Answer: Yes, it does.
