  - A. <u>Question</u>: Please clarify what the Fidelity Bond requested in item #3 of Section W. Insurance should cover?

<u>Answer</u>: The Fidelity bond can also be substituted for a Crime policy. Because the electricians will be on site, crime coverage is needed for any criminal acts committed by their employees.

B. <u>Question</u>: Please advise regarding the cost of the bond, is there a place on the price sheet to add the rate of the bond to be included on the Bid?

<u>Answer</u>: The pricing submitted should incorporate all costs of doing business into the hourly rate. Alterations to the Price Schedule may result in the Bidder being deemed non-responsive and its bid may be rejected.
