ADDENDUM NO. 2

Invitation to Bid (ITB) No. 22-101519, 2022 LMIG Road Resurfacing Projects (365 Day Contract) is hereby modified as follows:

1. **The bid due date has been extended to Thursday, August 11, 2022 @ 3:00PM.**

2. We have received questions pertaining to this ITB. The questions and responses are provided below:

a. Question: Who will be responsible for removing the abandoned vehicles located in the paving areas?

Answer: The county inspector or his/her representative shall contact DeKalb Police Department and follow standard protocol to have the vehicle(s) towed/removed.

b. Question: Who will be responsible for removal of household trash and refuse garbage from the paving areas?

Answer: The contractor shall be responsible for removing any objects/trash from the roadway. This item is found under the General Conditions section of the contract document.

c. Question: Several roads have low-lying limbs over the roadway that will interfere with the paving operations, who will be responsible for removing these limbs?

Answer: As specified under the General conditions section of the contract, the contractor shall be responsible for removing low-lying limbs.

d. Question: Would the County consider applying the GDOT Liquid Index Specification to this ITB due to the volatility of the Oil/Petroleum markets?

Answer: No.

e. Question: Can the County provide a typical section for the GAB section listed on the roads under the Surety Bond Streets "Addendum" list. Depending on the depth of the GAB, who will be responsible for utility locations and or relocations of conflicts

Answer: Yes, we can provide a typical section. Please see the attachment to this addendum. The contractor shall be responsible for calling in the utility locate; we will not relocate any utilities.

f. Question: Will the County allow the Contractor to place temporary tape on the milled sections prior to the final topping being placed?

Answer: No, all milled sections of roadway shall be paved the same day as stated in the contract document.

g. Question: Some of the streets in the Surety Bond Streets "Addendum " list are Condos/Apartment areas. Are the parking areas to be resurfaced or just the main roads around the Condos/Apartments?

Answer: Yes, the parking areas are to be resurfaced.

h. Question: Currently there is not a pay item for permanent striping (Thermo or Paint), will this be the responsibility of the contractor or the County. If the Contractor is responsible, can the County add a striping pay item.

Answer: Under the LMIG projects, the County shall be responsible for placing all permanent striping.

3. It is the responsibility of each bidder to ensure that he is aware of all addenda issued under this ITB. Please sign and return this addendum. You may email Angel Frazier at amfrazier@dekalbcountyga.gov before the bids are due to confirm the number of addenda issued.

4. All other conditions remain in full force and effect.

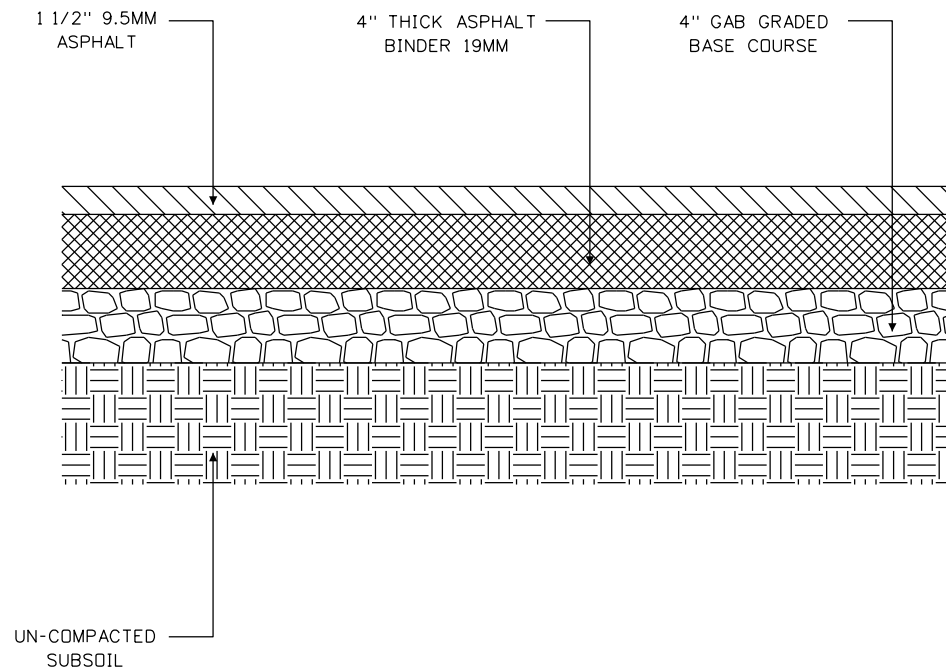
