## ADDENDUM NO. 1

Request for Proposals (RFP) No. 21-500590 for Workforce Innovation and Opportunity Act (WIOA) One-Stop Operator (Annual Contract with 3 Options to Renew) is hereby amended as follows:

- 2. We have received questions/comments pertaining to this RFP. The questions and their resulting answers appear below:
  - A. What is the name of the current contractor?

B. What year did the contract begin?

C. What is the current contract value?

Answer: Contract 1061955 is for an Amount Not to Exceed \$526,600.00.
