4.	Question: Will there be an opportunity to do the measurements ourselves?
	Answer: Yes, during the scheduled site visit.
5.	Question: What additional details are you willing to provide, if any, beyond what is stated in the documents concerning how you will identify the winning bid?
	Answer: Management team will select the carpet based on color, carpet, strength, quality based on the carpet samples (sections) observed.
