Briarcliff Road Handrail Installation

DeKalb County is seeking qualified bidders to provide all material, equipment, and labor for installation of handrail at Briarcliff Road:

1. Provide and install 548 feet of pipe handrail per GDOT standard detail 9031R as noted on the attached location map. The finish on all handrails shall be powder coat black. All joints shall be welded. The handrail is to be installed between the sidewalk and the decorative street light posts. The handrail is to go behind the traffic signal pole. Care is to be taken to avoid damaging underground electrical lines (marked in the field) for the decorative streetlights.

2. Demolish and remove from the site the existing handrail sections in conflict with the new handrail.

3. Removal of all construction debris is included.





IMPORTANT NOTICE

Insurance must meet the County's requirements and will be furnished by the successful Bidder(s) upon award.

- 1. Successful Bidder(s) will advise their insurance agent of the County's requirements as listed below and that they may not proceed with any work until insurance is provided that is in compliance with these requirements.
- 2. Contractor's insurance company or agent must mail, email, or bring an Original certificate of insurance and applicable declarations or endorsements to the DeKalb County address listed within this Insurance provision. Insurance must be from companies able to do business in Georgia and acceptable to the County as follows:
 - a. Certificates must cover:

i. Statutory Workers Compensation by accident. ii. Employer's liability insurance each accident \$1,000,000 iii. Employer's liability insurance by disease, policy limit \$1,000,000 iv. Employer's liability insurance by disease, each employee \$1,000,000 v. Business Auto Liability Insurance with a minimum \$500,000 Combined Single Limit/Each Occurrence (Including operation of nonowned, owned, and hired automobiles). vi. Commercial General Liability Insurance

- b. DeKalb County, GA shall be named as Additional Insured under any General Liability, Business Auto and Umbrella Policies. Coverage shall apply as Primary and non-contributory with Waiver of Subrogation in favor of DeKalb County, Georgia. Such additional insured coverage shall be endorsed to Contractor's policy by attachment of ISO Additional Insured Endorsement forms CG 20 10 10 01 (ongoing operations) and CG 20 37 10 01 (products- completed operations), or form(s) providing equivalent coverage.

- c. the coverage provided for the named-insured Contractor. It shall apply as primary insurance before any other insurance or self-insurance, including any deductible,
- d. Contractor agrees to waive all rights of subrogation and other rights of recovery against the County and its elected officials, officers, employees or agents, and shall cause each Subcontractor to waive all rights of subrogation for all coverages.
- e. Certificates shall state that the policy or policies shall not expire, be cancelled or altered without at least sixty (60) days prior written notice to the County.
- f. Contractor understands and agrees that the purchase of insurance in no way limits the liability of the Contractor.
- g. The insurance carrier must have a minimum A.M. Best's rating of not less than "A" (Excellent) with a Financial Size Category of VII or better.
- h. Certificates to contain policy number, policy limits and policy expiration date of all policies issued in accordance with this contract.
- i. Certificates to contain the location and operations to which the insurance applies.
- j. Certificates to contain successful contractor's protective coverage for any subcontractor's operations. If this coverage is included in General Liability, please indicate on the Certificate of Insurance.
- k. Certificates to contain successful contractor's contractual insurance coverage. If this coverage is included in the General Liability, please indicate this on the Certificate of Insurance.
