Attachment A

Animal Shelter Kennels

Scope of Work

Animal Shelters

Vendor to provide a total of ten (10) units to support housing 12 animals per shelter unit (12 x 10 = Housing for 120 Animals) and constructed "offsite" within a prefabrication process. Units shall be "fully assembled" animal shelter structures and delivered to the site ready, full assembly, as shown in the Drawings ready for connecting to utility connections. Each individual animal shelter structure (approx. 20 ft x 60 ft) shall support the animal living quarters for twelve (12) individual separate "housed dogs" within a single Housing unit.

There shall be a total of ten (10) individual modular Animal Housing Structures provided that will be constructed "offsite". The separate Housing Units (buildings) total ten (10) individual separate "*Modular units*". *Each Housing unit* will be delivered and <u>set by the Vendor</u> on ten (10) prepared separate concrete slabs at the listed site location.

Site Location

The site is located at the existing DeKalb County Animal Shelter:

Dekalb County Animal Shelter 3280 Chamblee -Dunwoody Road Chamblee, Ga 30341

The proposed new overflow Animal Shelter construction site is located directly adjacent to the "South side" of the existing Dekalb County Animal Shelter. This site is directly SW of the existing shelter facility and contiguous with the adjoining property Owned by the Dekalb County Dekalb Peachtree Airport.

Shelter Structures-Site Utilities

Each individual modular animal shelter structure shall support the living quarters for twelve (12) individual animals (dogs). A total of **ten (10) separate individual modular** units – "animal housing shelters" *shall be provided* to support the living quarters for a total of one hundred twenty (120) animals.

Each dog (animal) shelter shall be constructed off site (prefabbed) by a Company that is highly specializes in the Animal Shelter Prefabrication business and is currently in the business of building modular dog kennel shelters.

Each individual modular kennel shelter (kennel shelter house 12 dogs) shall be delivered to the site, off *loaded by the Vendor*, and placed by the Vendor on the Owner's "preconstructed" concrete slab foundations (individual concrete slabs) constructed by the Owners General Contractor- Hawk Construction Inc..

The Owner will have preconstructed ten (10) separate concrete foundations with needed service utilities "in- place" (preconstructed by the Owner's General Contractor – Hawk Construction Inc.).

The Animal Shelter Vendor shall plan for delivery and setup for ten (10) separate Units that house – a Total of 120 Animals. The buildings (kennels) are to be prefabricated off site and delivered by the Vendor to the listed address. The Animal Housing Vendor shall offload and place individual housing units on the Owner's pre -constructed concrete foundations per the Site Drawings.

The Owner will have constructed "in place" ALL required needed utilities (water / sewer / electrical) to each of the ten (10) individual Animal Shelters. Owner's site Contractor (Hawk Construction Inc.) will provide and install the necessary field utility service connections to the prefabricated individual shelters (kennels) per the Site Drawings.

Vendor to furnish to the Owner; ALL needed building utility assembly details to include shop drawings necessary to coordinate construction of ALL site utility tie- in activities to the individual units with the Owner and the various onsite Subcontractors that may be employed by the Owner.

Attachment B

Minimum Specifications

Modular 10 Housing Units -Housing 12 Animals per Shelter- Prefabricated Modular Shelter (120 animals)

Offsite prefabrication of 10 Individual Animal Housing Units (kennels) forming individual housing units (buildings each sized 20 ft x 60 ft) that provides kennel housing for dog capacity (12 Animals per housing unit x 10 Housing Units for a <u>total of 120 Animals</u>) shall include the following detail quality adds to each kennel and include:

Architecture:

- Add a deluxe Trim package
- Provide for standing seam metal roofing
- Provide Gable vents at each the Housing units
- Provide for <u>metal siding</u> walls: ALL exterior finishes (Patian Green finish color)
- Provide for a bone white "standing seam" metal roof
- Provide two (2) entrance /exit <u>insulated metal doors</u> with -9 glass lite entrance doors that are pre-hung with metal frames, include <u>exit-entrance doors</u> with hardware. See Dwgs for locations
- Provide for four (4) exterior walls mounted, 9 glass light, high grade <u>metal framed</u> <u>double pane insulated windows</u> that are min 30" x 60" size and constructed with aluminum frames with insulated glazing.
- Provide guillotine type individual animal exit door locks (door controls mounted outside the caged enclosure) to allow employee safe operation and to allow safe access for dogs in or out of their confined spaces.
- Provide for individual animal housing runs with galvanized metal dividing fencing with reduced smaller openings that have openings sized small enough to prevent any by side x side adjoining animal fighting resulting in injury due to animal behavior. Desire is to reduce access to an adjoining housed animal and retain open air concept yet results in prevention of animal biting injuries due to adjoined side by side housed animals.
- Provide water resistant water retardant wall inside panels (see Dwgs.) to prevent and resist mildew due to wet conditions from interior wall "wash down" cleanup activities.
- Provide for wall hung food service cabinetry with 6' long working service countertop and food+ dish storage shelving (min 6 shelves below and above the countertop).

Electrical

- Provide an electrical breaker box (min 100 amp), 15-20 Amps breaker switches, provide for multiple electrical outlets (minimum of 4-6) and lighting (add electrical package
- Provide for total of two (2) exterior flood lights at opposite ends of each animal shelter building
- Provide for minimum of eight (8) ceiling mounted <u>LED lighting fixtures</u> with wall mounted switches with adjustable dimmer operators

Mechanical & Plumbing

- Provide for exiting of ALL interior moisture accumulations by providing three (3) electric ceiling mounted air ventilators (restroom ceiling mounted type) discharging through the attic ventilation with flexible ducting to exterior environment. Provide the necessary electrical on /off control switches (min of 2) mounted conveniently on the walls adjacent to the entrance / exit doors.
- Provide two (2) HVAC wall mounted electrical HVAC (heating -cooling) units
 that are wall mounted at each end of the housing units. Each HVAC unit shall be
 adequately sized and complete with controlled select air tempered temperatures
 for heating and cooling. Housing HVAC Units shall be conveniently wall
 mounted and provided with temperature control thermostats with easily seen large
 numbers and temperature readings.
- Provide two (2) Exterior Water Hose Ports
- Provide an <u>electric hot water tank</u> unit (min 40 gallon and adequately sized that can be securely wall mounted) and provided with an overflow drain pan.
- Provide a floor mounted large housekeeping sanitary "wash <u>service Sink"</u> with functional plumbing and with sewer drain connections. Unit to include hot and cold-water service connections for cleaning animal service dishes.
- Provide for a floor positioned "mop sink" with hot and cold-water utility plumbing services to include sink floor drainage plumbing.

Qualifications

The Prefabrication Animal (dogs) Housing Company (Vendor) shall directly specialize in Commercial Dog Kennel Housing Construction. Specialized dog business services to include Dog Kennel Housing prefabrication construction process and complete design services in animal (dogs) care housing unit construction.

Animal Housing Prefabrication Company shall have been in like kind business of the prefabrication process / kennel design services / and construction services of large (order of magnitude: 6 or more dog capacity per Housing unit –minimum) Animal (dogs) Prefabrication Housing Construction for a business period minimum of five (5) years.

The bidder must have an active business license in the State where the Prefabrication building process operates.

Housing Unit Fabrication Pre-sign off /Plant Inspection of Fabrication Unit

Vendor shall obtain the Approval of the Owners representative prior to construction of more than one (1) unit with the Owners <u>inspection at the Vendors</u> "offsite" fabrication <u>facility</u>. This signoff of the 1st unit that is prefabrication at the Vendors off site location is required to confirm the materials of construction, workmanship detail, and utilization of the materials to be constructed as a part of the Housing Units.

The fabrication assembly plant "site visit" by the Owner shall review the assembly /construction quality in workmanship details and selection of materials for an expected high level of workmanship by the Fabricator.

The Owner's signoff of the prefabricated first (1st Unit ready for inspection) will be coordinated by the Vendor and Owner. The required notification shall be direct to the Owner's Project Manager that will coordinate a time and location for an onsite **plant visit** to allow confirmation of the selected standard of quality in fabrication.

A <u>one week's advanced Notice</u> by the Selected Housing Vendor for a fabrication site visit of a completed Unit for the Owner to review the acceptable constructed "standardize of quality-built off-site fabrication."

The Owner will visit the Vendors fabrication site upon advanced Notice by the Vendor.

Anticipated personnel for a *plant site visit* may include: the Owners General Contractor / the Owner's Project Manager / the Owner's Animal Shelter Operator.

All travel costs for the Owners Team for planned site visit is at the Owner's costs.
