



## Proposed Substantial Amendment to the 2019-2023 Consolidated Plan, including the 2020 Annual Action Plan

DeKalb County is proposing to amend to the 2019-2023 Consolidated Plan, including the 2020 Annual Action Plan to include an allocation of funding from the Coronavirus Aid, Relief and Economic Security Act (CARES Act) (Public Law 116-136) made available in supplemental Community Development Block Grant (CDBG-CV1 and CDBG-CV3) totaling \$6,833,632. In addition, include an amount of CARES Act Emergency Solutions Grant Program funding (ESG-CV1 and ESG-CV2) totaling \$5,412,468 to respond to the effects of the current historic public health crisis.

CDBG-CV1 and CDBG-CV3 funding will be used for a range of eligible, activities that prevent, prepare for, and respond to the Coronavirus pandemic. Eligible activities include building and improvements including public facilities; including special economic development assistance; provisions of new or quantifiably increased public services such as housing assistance, food, and emergency assistance; planning, capacity building and technical assistance.

ESG-CV1 and ESG-CV2 funds were granted to enable the County to prevent, prepare for, and respond to coronavirus among individuals who are homeless or receiving homeless assistance and to support additional homelessness assistance and homelessness prevention activities. The County may use funds to provide eligible services that include the following activities: Rapid Re-housing, Prevention, Outreach, Emergency Shelter, Data Collection, Administration, and all additional, eligible ESG-CV activities (Temporary Emergency Shelter, Training/Conferences, Handwashing Stations, Landlord Incentives and Volunteer Incentives). DeKalb County has already implemented many of the eligible activities. However, as of this date, none of the activities have received funding from the ESG-CV allocation.
