DeKalb Interim CEO May Announces New Fire Chief

Former Fulton Deputy Chief Tapped for Top Job

DECATUR – DeKalb Interim CEO Lee May announced that Darnell Fullum, currently Deputy Fire Chief in Fulton County, will be the permanent chief of the DeKalb County Fire and Rescue Department.

"This has been an unprecedented process in which we solicited input from the Board of Commissioners, the front-line first responders and the public at large," said Interim CEO May. "I am proud to announce that, after an extensive nationwide search, Darnell Fullum has accepted the position. DeKalb County will be in very capable leadership."

In August, DeKalb County began a national search for a new Fire Rescue Chief. Human Resources conducted interviews with candidates deemed highly qualified for the job. From 110 applications, the field was narrowed to the top candidates who were interviewed by a panel of subject matter experts from surrounding jurisdictions, including a mayor from a city in DeKalb County and a representative from DeKalb County Board of Commissioners. Interim CEO May chose two finalists including Fullum and hosted two televised public forums in which candidates were interviewed.

Fullum has been with the Fulton County Fire Department for 26 years, rising through the ranks to the position of Deputy Chief, a position he has held since 2008. Fullum's resume is attached.
