Rubber Removal RWY 3R/21L and Remarking of Entire Airfield

Date: Monday, August 13, 2018

PROJECT UPDATE:

Phase 1 installation of the Engineered Material Arresting System (EMAS) at DeKalb Peachtree Airport which began on July 5, 2017, is complete. Phase 2's date has been revised due to 4 inches of rain on our airfield last week. Our revised schedule is listed below:

- I. Phase 2 revised scheduled will begin August 27, 2018-September 25, 2018. This phase will last approximately 30 days, weather permitting.
 - A. During Phase 2, RWY 21L will have a declared Landing Distance Available (LDA) of 4,551'.
- **II. Phase 3** scheduled for **September 26, 2018 November 24, 2018**. This phase will last approximately 60 days, weather permitting.
 - A. <u>First 30 Days (Sept. 26 Oct 25):</u> Construction will take place 24 hours a day, 7 days a week. Please be advised working crews and equipment will be on the airfield. The localizer will be inoperable during this time.
 - 1. Daytime operational hours: 6AM-8PM
 - a. RWY 21L Arrivals & Departures: TODA 6001'; TORA 5551'; ASDA 5551'; LDA 4551'
 - 2. Nighttime operational hours: 8PM-6AM
 - a. RWY 3R Departures from TWY Foxtrot only
 - B. <u>Last 30 Days (Oct 26 Nov 24):</u> Due to the construction grades in front of the localizer and at the end of the runway the localizer will be inoperable during this time.
 - 2. Daytime operational hours: 6AM-8PM
 - a. RWY 3R Departures from TWY Foxtrot only
 - 3. Nighttime operational hours: 8PM-6AM
 - a. RWY 21L: Arrivals & Departures TODA 6001'; TORA 5341'; ASDA 5341'; LDA 4341'

- C. All other runways will be fully operational on regular schedule.
- D. Rubber removal and airfield remarking to be completed during this phase
 - 1. RWY 3R/21L will be closed for 72 hours over a weekend in September in order to complete this work. All tenants will be given prior notice of exact dates.
- **III. Phase 4** scheduled for November 25, 2018-December 25, 2018. This phase will last approximately 30 days, weather permitting.
 - A. Hours of operation for all runways will return to normal schedule
 - B. Installation of the EMAS Blocks will be done outside of the Runway Safety Area (RSA)
 - C. All NAVAIDS will be back up and operational.
 - D. RWY 3R: TODA 6001'~ TORA 5411'~ ASDA 5411'~ LDA 5411'
 - E. RWY 21L: TODA 6001'~ TORA 6001'~ ASDA 6001'~ LDA 5001'
