OUTREACH: Outreach teams begin the coord entry process when they encounter unsheltered homeless with highest barriers to accessing our system, and provide information & info cards so those who are not immediately ready to participate can later.

ADVERTISING: Information about our system is shared widely: Newspaper advertisement for process; Information provided to local churches, school systems, & other organizations; Flyers in stores and businesses where the homeless frequent; Info in United Way 211 system & on County and organizational websites. Staff makes presentations at community meetings to tell the genrl public the process. Policemen, Court workers, judges, hospital workers, County jail workers/other County workers who encounter the homeless are trained on the system.

ACCESSIBILITY: CoC in agreement with a vendor to show homeless provider information on an easily accessed telephone app so that ppl can find a location to help the homeless. Process info provided to Latin American Association & Refugee Family Services, & Immigrant Svc Council for translation & distribution to non-English speakers.
