### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Using a Housing First approach, the DCM Interim Housing Project will provide up to 12 months of crisis housing without preconditions for those families with higher needs and who are the most vulnerable. Families will be assessed and, based on client choice and appropriate level of intervention, will be provided transitional housing or rapid re-housing services. These services will be provided to homeless families who fall under Category 1 or 4 of the final rule’s definition of homelessness. Transitional units are scattered site, community-based units. Funding for this project would make possible leasing payments for TH units and rental payment for PH-RRH units, case management, and supportive services. The program staff of the TH/RRH program will work with each family to develop an Individualized Service Plan (ISP). The ISP details the households’ short- and long-term goals around housing, income, health and basic needs. Information received from the family’s needs assessment and ISP inform the intensity and direction of the case management delivered and the types of resources to which the family will be connected. The ultimate goal of the program is to rehouse families as quickly as possible, breaking the cycle of homelessness among families who have the greatest barriers to housing stability. The indicators of success for the TH/RRH project are that 85% of the families placed in the project will be discharged to permanent housing destinations. In addition, 80% of transitional housing residents who exit to permanent housing will remain housed for 12 months. To achieve these outcomes DCM will continue to partner with housing and family service agencies to include linkage to mainstream benefits. Staff will prioritize client choice while providing financial assistance, individualized case management, and supportive services to ensure clients successfully retain or obtain permanent housing.

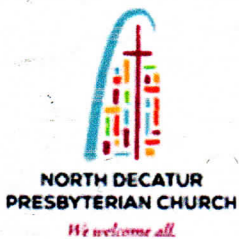
