3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The CaringWorks Shelter Plus Care I DeKalb grant provides permanent supportive housing for 29 homeless single men and women in DeKalb County. The majority of our clients in this program are middle aged, 100% are chronically homeless, 81% are mentally ill and 58% have substance abuse issues. As part of this program, participants receive safe housing in single bed apartments, intensive case management, connection to supportive services and mainstream benefits and client assistance such as transportation and food supplies on an as needed basis.

Clients are referred to CaringWorks by partner agencies and must have a verification of homelessness that follows the standard verification requirements as detailed by HUD guidelines. Upon arrival into the CaringWorks Permanent Supportive Housing Program, clients are assigned a case manager. CaringWorks' case managers follow a Housing First model and work with each client to develop an Individual Resiliency Plan that outlines their goals and challenges as it relates to achieving stability.
