Jerusalem House is seeking funding for its Scattered Site Program. The purpose of the program is to provide permanent housing and supportive services for homeless adults and families with HIV/AIDS. These adults or families often go from transitional or program situations to independent housing, where supportive services are lacking. As a result, they often fall back into the cycle of homelessness. The Jerusalem House program would allow homeless individuals and families living with HIV/AIDS access to 19 units of independent housing with supportive services in place.

Program residents will be selected without regard to race, color, sexual orientation, age, religion, national origin or ancestry. Residents may include men or women, eighteen and older, who are in recovery from substance abuse and individuals with mental illness. 

This is in response to your inquiry dated <u>May 14, 1997</u>, requesting a copy of the letter which granted tax exempt status to the above named organization.

Our records show that the organization was granted exemption from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code effective May 1989 . We have also determined that the organization is not a private foundation because it is described in sections 509(a)(1) and 170(b)(1)(A)(vi).

Donors may deduct contributions to you under section 170 of the Code.

As of January 1, 1984, you are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more you pay to each of your employees during a calendar year. You are not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

You are required to file Form 930, Return of Organization Exempt From Income Tax, only if your gross receipts each year are normally more than \$25,000. However, if you receive a Form 990 package in the mail, please file the return even if you do not exceed the gross receipts test. If you are not required to file, simply attach the label provided, check the box in the heading to indicate that your annual gross receipts are normally \$25,000 or less, and sign the return.

A copy of our letter certifying the status of the organization is not available, however, this letter may be used to verify your tax-exempt status.

Because this letter could help resolve any questions about your exempt status, it should be kept in your permanent records.
