The APR for the most recent grant term was delayed due to being impacted by a change in the Homeless Management Information System within the COC and state of Georgia as well as the change to the SAGE system. The new HMIS vendor had not completed the needed data/CSV process to provide a data export for using the SAGE system during the time the APR was due and the COC/Georgia received an extension of time for compliance. Additionally, during data migration to the new Client Track system there was significant data issues as well as the discovery of missing data from the previous system which required re-entering data more than a year previous for all clients. With the new Client Track system now fully migrated and functioning better along with increasing case management training for how to use the new HMIS system, we believe the next cycle APR will be completed on-time.

It was the third year of the new project. During the first year of the project there were significant funds in operations for initially furnishing all apartments. Not as much is needed in subsequent years for new furniture – although future years will need replacement furniture – which contributed to funds not being spent in the grant cycle. We are speaking with the COC on how to initiate a contract amendment to move much of these funds to the services area to provide more transportation, food and other eligible service support to participants to ensure all funds are spent and that families receive as much assistance for long-term impact as possible.

**1. Provide a description that addresses the entire scope of the proposed project.**

The DeKalb COC has 48% of its homeless as families and is a priority for COC efforts. The New Horizons Program provides 20 chronically homeless families with disability, representing approximately 65 parents and children, permanent apartment-based housing to ensure stability as well as intensive case management support to identify and address family needs. COC program funding is vital as a unique source of housing funds for this unique group not available elsewhere. Any composition of homeless family is accepted as long as there is a minor child. Families are enrolled into the program based on the COC's Coordinated Assessment & Intake process. The program follows a housing first model, including no barrier to entry based on lack of income, sobriety or other issues and includes best practices such as harm reduction approaches. Leases are in the name of Nicholas House to eliminate initial rental barriers due to family history or lack of income. Our goal is 80% remain housed and 75% maintain/increase income over the year. A mix of two & three bedroom furnished units are available for various family sizes and located in two communities on mass transit lines. Housing barrier assessments are conducted and needs identified to create a service plan. A case manager ensures services are provided to support the goals and actions in the plan with monthly in-home meetings plus other contact as needed. Families participate in efforts toward self-sufficiency as they desire and encouraged to do so. All mainstream benefits for which the family may qualify are immediately assessed and applied for to establish benefits. Connection to health assessments and treatment plans also are done. The focus on parents includes reducing barriers to housing (mental/physical health, addiction, poor credit, evictions, criminal history), increasing current cash flow and future earning potential (GED, education, job training, job search), and changing poor decision making patterns that lead to creating new housing barriers. For children, coordination with the school system ensures child educational progress with supplemental tutoring provided as needed and access to mental health services to address any social and behavioral needs. Collaborative partners are identified for services needed by families, including mental/physical health, job training, childcare and others. Nicholas House pays all rent monthly (to include utilities with lease); however parents may pay an occupancy charge per HUD rent calculation requirements to help establish budgeting patterns and accountability.
