3B. Project Description

St. Jude's Project Open Arms serves chronically homeless and disabled veterans recovering from alcohol and drug addiction and psychiatric disorders, including PTSD. Both men and women are served.

The program provides clients with safe, permanent housing; improved opportunities for employment; and the support needed to live sober, self-sufficient lives. Clients also receive case management. Case Managers meet with clients weekly to provide recovery support and links to any needed outside community services. Ongoing case management helps clients maintain sobriety and employment.

The program serves 30 men and women at any given time. Participants reside in 24 one-bedroom apartments and 4 two-bedroom apartments.

Outcomes include maintaining or exiting clients into permanent housing and helping clients maintain or increase their earned income. In the new grant term, St. Jude's anticipates that 80% of clients will maintain or exit into permanent housing. St. Jude's anticipates that 80% of clients will also maintain or increase their earned income. Both outcomes are necessary for developing self-sufficiency.
