St. Jude's Welcome Home Program serves chronically homeless women with dependent children. Participants are recovering from alcohol and drug addiction and other co-occurring disorders, such as mental illness. The program provides the women and their children with safe, permanent housing; improved opportunities for employment; and the support needed to live sober, self-sufficient lives.

The program serves up to 6 women and 18 children at any given time. Clients reside in 6 apartments, 3 three-bedroom apartments and 3 two-bedroom apartments.

Women in the program receive weekly, on-site support services by Case Managers that include case management, employment services, recovery support services, and access to wrap-around services. Ongoing case management helps clients maintain sobriety and employment. In addition, relapse prevention groups and access to 12-Step meetings are provided.

Outcomes include maintaining permanent housing or exiting clients into independent housing and helping clients maintain or increase their earned income. For the new grant term, St. Jude's anticipates that 80% of clients will maintain residence in permanent supportive housing or exit into independent housing. St. Jude's anticipates that 80% of clients will also maintain or increase their earned income. Both outcomes are necessary for developing self-sufficiency.
