### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

This program will assist a minimum of (six) 6 literally homeless households and/or individuals with housing relocation and stabilization services, medium-term rental assistance, and intensive case management. There are no income eligibility requirements established by the program, and we will utilize a Harm Reduction approach in order to reach the neediest and most service resistant homeless persons in DeKalb County. Referrals will come from the DeKalb CoC's Centralized Intake and Assessment System. At least 80% of those assisted will achieve stable, permanent housing.

In addition to providing financial assistance, the program also provides intensive case management and supportive services in order to help clients achieve success. With their assigned case manager each household develops an Individual Service Plan (ISP) that outlines short and long term goals needed to achieve financial stability and stable housing. The ISP is tailored to meet the unique needs of each individual household, but typically includes budget planning and credit repair, accessing mainstream benefits and services, employment assistance, life skills training, housing advocacy, and assistance with supplemental needs such as transportation, food, and childcare. Many of these services are provided in-house, but for those that are not, consumers are provided with referrals to other service providers. Participants expected to maintain regular contact with their case managers to demonstrate that they are actively working towards achieving the goals outlined in their ISPs.

A Harm Reduction approach will be used to meet the client where they are at currently in their lives and the ISP will reflect positive planning without being used as a tool to force specific behaviors or as a punitive enforcement document. The primary purpose of this program is to assist participants in obtaining and remaining in permanent housing that fits their needs. While housing choices are ultimately made by the consumers themselves, case managers will facilitate the process and help ensure wise decisions are made. A large part of this guiding process includes budgeting, financial planning, and ensuring that housing choices meet rent reasonableness and habitability standards. The ISP becomes the roadmap for improving income, becoming financially stable, accessing mainstream benefits, and ultimately achieving permanent, stable housing.

Housing is determined by participant choice and therefore can be located anywhere within DeKalb County. A major factor in making that choice will be access to amenities in the immediate vicinity including public transportation, schools, day care, after-school programs, grocery and drug stores, medical facilities, and any other specific need.
