### VII. Acceptance of February 26, 2021 Minutes

VIII. Chairperson Adrienne McMillon and AOC Members discussed the interview process of potential candidates for the DeKalb County Senate Delegation to the AOC. "The Committee authorized the chairperson and vice chairperson to conduct interviews for the open Committee seat on behalf of the Committee."

### IX. CAE Update: John Greene, Chief Audit Executive, reported on the following:

- The CAE stated that actuals for March are on track regarding budgeted expenditures.
- The CAE stated that Deborah Reeves was hired as an Internal Auditor and the OIIA is fully staffed.
- The CAE stated that on March 3, 2021, he presented the 2021 Annual Workplan to the DeKalb County Board of Commissioners.
- The CAE stated that the 2021 Work Plan was issued on March 10, 2021, and the 2020 Annual Report was issued on March 12, 2021.
- The CAE mentioned the Final Audit Reports issued in 2021 and Draft Reports issued for Management Response in 2021.
- The CAE talked about contract reviews issued in 2021 thru April 7, 2021, for a total reduction in contracts totaling \$1,890,425. In addition, he mentioned that since the Office of Independent Internal Audit begin these reviews in late 2018 that the reviews have produced a total reduction in contracts of \$48,742,725.85.
- The CAE reported that the OIIA has continued to conduct assignments on the current Work Plan in the following areas:

  - C. Vehicle Fuel Administration
