

DeKalb County Audit Oversight Committee Summary of June 23, 2021 Meeting

Pursuant to O.C.G.A. § 50-14-1(e)(2)(A), the following is a summary of the subjects acted on and those members present at the June 23, 2021 meeting of the DeKalb County Audit Oversight Committee (AOC):

- 1. The Meeting was called to order at 12:04 p.m. by Chairperson Adrienne McMillon. Members present were Chairperson Adrienne McMillon, Vice Chairperson Harold Smith Jr., Lisa Earls, and Clair Cousins.
- 2. The Committee adopted its agenda for this meeting by all members present at the time of the vote.
- 3. There were no public comments.
- 4. Members of the Committee approved the payment of invoice for legal services provided in April 2021 and May 2021.
- 5. The minutes of the April 23, 2021, meeting was approved with a correction by all members present at the time of the vote.
- 6. Chairperson Adrienne McMillon and AOC Members discussed the interview process of potential candidates for the DeKalb County Senate Delegation to the AOC.
- 7. CAE Update: John Greene, Chief Audit Executive, reported on the following:
 - The CAE stated that actuals for April and May are on track regarding budgeted expenditures.
 - The CAE stated that Yolanda Lockett is currently managing the IT team to replace Jin Veeranarong who resigned in May.
 - The CAE stated that Deborah Reeves was hired to replace Ralph Igwedibie who transitioned to Planning and Sustainability in April.
 - The CAE discussed the five-year report that will be issued in July highlighting what the office has accomplished since it started on September 26, 2016.
 - The CAE reported that the OIIA has continued to conduct assignments on the current Work Plan in the following areas:

 - D. Vehicle Fuel Administration
 - E. Water Billing Process
 - F. Terminations and Transfer of Employees
